ORDER

WHEREAS, the institution namely **Sun College of Education, Sun Nagar, Erachakulam Post, Kanyakumari, District – 629902, Tamilnadu** was granted recognition for conducting Secondary (B.Ed.) course of one year' duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.SRO/NCTE/2007-2008/1884 dt.28.05.2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, provisional revised recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.

AND WHEREAS, on 10.11.2015 the institution submitted the staff list which is neither approved by the affiliating body nor the same is according to NCTE Regulations. 2014. As per the general decision of SRC, an inspection letter was issued to the institution on 14.06.2016 but the same was not carried out / implemented.

AND WHEREAS, A request letter dt. 10.12.2018 was received from the institution *inter-alia* requesting the following:

1. Request for change the name of institution from “**Sun College of Education**” to “**Amrita College of Education**”.
2. Request for change the trust from “**ACP Educational Trust, 10, Kalaimagal Street, Nagercoil, Kanyakumari**” to “**Mata Amritanandamayi Math, Amritapuri, Kollam, Kerala.**”

AND WHEREAS, a letter was issued to the institution vide dated 07.01.2019. Now, the institution vide letter dated 22.01.2019 has informed that the Sun College of Education is presently affiliated to TNTE University, Chennai and has requested to send the earlier communication dated 07.01.2019 to TNTE University. Here, it is pertinent to mention that the college has not submitted compliance of RPRO issued to the institution on 05.05.2015 except the faculty list which is neither approved nor the same is according to NCTE Regulations, 2014.

AND WHEREAS, the above matter was put before the SRC in its 379th meeting held on 21st-22nd August 2019 and the Committee considered the matter and decided *issue Final Show Cause Notice*. Accordingly, a Show Cause Notice was issued to the institution on 06.09.2019. Thereafter, the institution submitted its reply along with documents on 09.12.2019.

AND WHEREAS, the institution along with regulatory file was placed before the SRC in its 383rd meeting held on 07th -09th January 2020 and the decision of the Committee is reproduced below:

“The ACP Education Trust vide its Executive meeting held on 04.12.2017 at Nagarcoil vide item No. 5 have resolved to Change the name of the Trust from ACP Educational Trust at No. 19, Kalaimagal Street, Nagercoil, Kanyakumari District to Mata Amritanandamayi Math, at Amritapuri (P.O), Kollam, Kerala, vide application ref. no. ACP/2327/41/2017-18, date 23.01.2018 made by the ACP Educational Trust address at No. 19, Kalaimagal Street, Nagercoil, Kanyakumari District, this is to confirm that the State Government of Tamil Nadu has no objection for change of Trust from ACP Educational Trust No. 19, Kalaimagal Street, Nagercoil, Kanyakumari District to Mata Amritanandamayi math, Amritapuri (P.O.), Kollam, Kerala. Liabilities, if any, on this count shall be the sole responsibility of the Applicant of the Trust and shall be settled as per the rules and Regulations as applicable”

In view of the above, the Committee decided to permit the change of the Trust from ACP Educational Trust No. 19, Kalaimagal Street, Nagercoil, Kanyakumari District to Mata Amritanandamayi math, Amritapuri (P.O.), Kollam, Kerala.

Further the Committee also decided to accept the request for change of the name of the institution from “Sun College of Education” to Amrita College of Education”.

The Committee also decided that the **continuation order** be issued to **Amrita College of Education, Kanyakumari, Tamilnadu** for **B.Ed** programme for **2 basic units (50 students each unit)** .

THEREFORE, the permission for change of name of institution and trust is accorded from “Sun College of Education” to “Amrita College of Education” and “ACP Educational Trust No. 19, Kalaimagal Street, Nagercoil, Kanyakumari District” to “Mata Amritanandamayi math, Amritapuri (P.O.), Kollam, Kerala” respectively.

NOW THEREFORE, this order is issued permitting the institution **Amrita College of Education Sun Nagar, Erachakulam Post, Kanyakumari, Tamilnadu** run by Mata Amritanandamayi Math, Amritapuri, Amritapuri (P.O.), Kollam, Kerala-690546 for continuation of conducting **B.Ed course of two years duration** with an intake of **100 students (two basic units of 50 students each)** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
