WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **Loyola College of Education, Rekurthy, Malkapur Post, Karimnagar-505451, Andhra Pradesh** run by **Jesuit Province Society, Karimnagar, Telangana** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed /2006-2007/836 dated 14.04.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC vide order no. F.No.SRO/NCTE/APS07032/B.Ed/TS/2017-18/94077 dated 21.07.2017 permitted the institution for one basic unit as per their request.

4. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 20.02.2019. The institution did not reply to Show Cause Notice till date.

5. **AND WHEREAS**, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 380th meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the Institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 10.10.2019. The institution vide letter dated 23.10.2019 submitted its reply to the Final Show Cause Notice.

7. **AND WHEREAS**, the SRC in its 382nd Meeting, the Committee considered the matter and decided issue a letter. Accordingly, letter was issued to the institution on 16.12.2019. the institution has submitted reply of letter on 05.03.2020.

8. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th – 14th December, 2021 considered the matter and decided as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 05.03.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has submitted faculty approval of 8 faculty vide letter 08.05.2019. The institution has not submitted faculty list in prescribed format approved by Affiliating University as NCTE Regulation 2014. The faculty strength is not enough for B.Ed. course (one unit) as per clause 5.3 of appendix of NCTE regulation 2014.
2. The website of the institute is not uploaded with the information required under clause 7(14)(i), 8(14) and 10(3) of NCTE regulation 2014.
3. The govt of A.P. vide proceeding dated 12.07.1892 had providing the land for high school and junior college.
4. The institute did not submit demarcated building plan for all the course.
5. Total build up area 3498.68 Sq.Mtr. is not enough for running high school, junior college, D.Ed. and B.Ed course.
6. The Building Plan and site plan submitted by the institution is not readable.
7. The institution has submitted photocopy of FDRs Rs. 3 lakhs + Rs 5 lakhs total 8 lakhs instead of "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to **withdraw the recognition** granted to **Loyola College of Education, Rekurthy, Malkapur Post, Karimnagar-505451, Telangana** for conducting **B.Ed.** programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

9. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Loyola College of Education, Rekurthy, Malkapur Post, Karimnagar-505451, Telangana** for conducting **B.Ed.** programme of two year duration with an annual intake of 50 students (one basic unit) for B.Ed. Programme with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school,

College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
