AND WHEREAS, the recognition was granted to the institution namely B.I Teacher Training Institute, Pallam P.O-686007, Kopttayam District, Kerala vide SRC (NCTE) order No. F./SRO/NCTE/98-99/5116 dated 25.01.1999 for conducting D.Ed. course of one-year duration with an annual intake of 40 students from the academic session 1998-1999

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 13.05.2015 for conducting D.Ed. course of two years duration with an annual intake of 22 students (two basic units) from the academic session 2000-2001.
- AND WHEREAS, the request of the institution was placed before SRC in its 385th Meeting held on 3rd March 2020 and the Committee decided to issue Final Show Cause Notice. Accordingly, a Final Show Notice issued to the institution on 13.03.2020 reply received in SRC office on 31.07.2020.
- AND WHEREAS, the request of the institution was placed before SRC in its The matter was further considered by the SRC in its 386th Meeting held on 23rd 24th July 2020 and the Committee decided to send a last reminder letter to the institution and Accordingly, a Reminder Letter issued to the institution on 05.08.2020 reply received in SRC office on 16.09.2020.
- AND WHEREAS, the matter was further considered by the SRC in its 389th meeting held on October 12th & 14th, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder Notice (Letter) dated 05.08.2020. The institution has submitted its reply on 16.09.2020. The Committee considered the reply and found the following deficiencies: -

1. The institution has submitted a notarized copy of land documents. However, a certified copy of land document has not submitted.

- 2. The institution has not submitted Land use certificate. However, institution stated that the building was constructed in 1865 prior to the Kerala building rules come into being. And hence, it was not possible to obtain permission for land use certificate. Land tax receipt enclosed. Land tax receipt is in regional language. Translated copy not submitted.
- 3. The institution has not submitted notarized English version of Latest Non Encumbrance Certificate duly approved by the competent authority.
- 4. The institution has submitted a copy of Building Plan which is not approved by the competent authority. The site area is not mentioned.
- 5. The institution has not submitted Building Completion Certificate in format duly approved by the competent authority.
- 6. The institution has submitted an original staff list approved by District Educational Officer, Kottayam vide dated nil. Some deficiencies in staff are:
 - a. It is consisting of one principal and three Lecturers against the requirement of 1+7 teaching staff as per NCTE Norms.
 - b. Principal does not have the qualification of P.hD. as per NCTE Regulation 2014.
 - c. Percentage of marks in PG degree of 2 Lecturers is less than 55%. The details are: -

 - i. "Annie Ninan" (Economics)
 ii. "MariammAphilip" (Mathematics)
 - d. Photographs of following faculty members are not affixed over the proforma submitted by the institution.
 - A. Jessy Vargeese- Principal
 - B. Annie Ninan-Economics
 - C. Jancy P A- Psychology
 - D. Mariamm- Mathematics
 - e. Faculty in r/o Fine Arts & Performing Arts not appointed.
- 7. The institution has not submitted "Form A" issued by the respective Bank Manager. However, the institution stated that we are a corporate management with 136 schools (LP, UP, HSS, ITE). All schools are operating after maintenance and have fitness certificate from the government authority. The salary of all school staff is given by the Government of Kerala. Therefore, the reserve found of each institution is not kept in separate account bank.

Hence, the Committee decided to withdraw the recognition granted to B.I Teacher Training Institute, Pallam P.O-686007, Kopttayam District, Kerala for conducting D.El.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to B.I Teacher Training Institute, Pallam P.O-686007, Kopttayam District, Kerala for conducting **D.ELEd. course** of two years duration with an annual intake of **22** students w.e.f. the next academic session.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
