ORDER

WHEREAS, the institution namely Dr. Palpu Memorial S.N.D.P Yogam College of Education, Kodungallur-680664, Thrissur, Kerala was granted recognition vide SRC (NCTE) order no. F.KL/SEC/10/SRO/NCTE/2002-2003/1521 dt. 03.07.2002 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution 2. by a notarized affidavit dt. 31.05.2015 consented to come under new Regulations.
- AND WHEREAS, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt.31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (two basic units) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.
- AND WHEREAS, a corrigendum was issued to the institution vide order No.F.SO/NCTE/AOS00141/B.Ed./KL/2015/69264 on 03.07.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the session 2015-2016.
- AND WHEREAS, SRC as per decision taken in its 380th meeting. The Sub-5. Committee of the SRC decided to be issued Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 21.10.2019. The institution vide letter dated 18.11.2019 & 11.11.2019 submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on 15th -16th December 2020 and the Committee decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Dr. Palpu Memorial S.N.D.P Yogam college of Education, Kodungallur 680664, Kerala for B.Ed programme for 1 basic unit

of 50 students.

In view of the request made by the management, the Committee also decided to withdraw the recognition granted for M.Ed course w.e.f. this academic session.

- 7. NOW THEREFORE, this order is issued permitting the institution continuation of conducting Dr. Palpu Memorial S.N.D.P Yogam College of Education, Kodungallur-680664, Thrissur, (Survey 17/6 Methala Village Building No. V 216/A) Kerala run by Dr. Palpu Memorial S.N.D.P Yogam College of Education, Kodungallur-680664, Thrissur, Kerala for B.Ed. course of two years duration with an intake of 50 students (one basic units of 50 student) subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities:
- g. Facilities added during the last quarter:
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
