AND WHEREAS, the recognition was granted to the institution namely, Meppayur Salafi College of Education, P.O. Lringath, Pin-673523, Kozhikode District, Kerala run by Meppayur Salafi College of Education, P.O. Lringath, Pin-673523, Kozhikode District, Kerala vide SRC (NCTE) order No.F.KL/SEC/06/SRO/NCTE/2000-2001/8513 dated 06.11.2001 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2001-2002.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 17.07.2019. In response, the institution submitted its written representation reply vide letter dated 30.07.2019 & 21.11.2019.
- AND WHEREAS, the matter was further considered by the SRC in its 387th Meeting held on August 24th & 25th, 2020 and the Committee decided as follows:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the Show Cause Notice's reply submitted by the institution on 30.07.2019 and 21.11.2019 and found the following deficiencies:

- 1. The institution has not submitted copy of Land Use Certificate issued by the competent authority.
- 2. The institution has not submitted copy of Non-Encumbrance Certificate duly approved by the competent authority.
- 3. The institution has not submitted original Building Plan duly approved by the competent authority.

- 4. The institution has not submitted copy of Site Plan duly approved by the competent authority.
- 5. The institution has not submitted copy of Building Completion Certificate duly approved by the competent authority.
- 6. The institution has not submitted copy of land document of registered land duly approved by the competent authority.
- 7. Original Staff list approved by the University of Calicut consisting of one principal, Six Assistant Professor and one part time Assistant Professor submitted.
- (i) Percentage of marks in r/o Principal & Assistant Professor in Education at (S.No.1 & 7) is less than 55%
- (ii) Principal & Assistant Professor at S.No.1, 6, 7 & 8 does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017

- (iii) The institution has not appointed Fine Art, Performing art & Physical Education teacher.
- 8. Details of Teacher Education programme (s) being run by the institution in the same campus not submitted.
- 9. Details of other programme(s) (if any) being run by the institution in the same campus not submitted
- 10. Details of total land & built up area for all the recognised Teacher Education programme/other programme (if any) being run by the institution in the same campus not submitted
- 11. Domain name of the website being run by the institution not submitted.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

- 6. AND WHEREAS, as per decision taken in the meeting 387th, a Final Show Cause was issued to the institution on **01.09.2020**. In response, the institution submitted its reply on **28.09.2020**.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 389th meeting held on October 12th & 14th, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 01.09.2020. The institution has submitted its reply on 28.09.2020. The Committee considered the reply and found the following deficiencies: -

- 1. The Institution has submitted notarized attested photocopy of Building Plan the same is not approved by the competent authority. Multipurpose hall size is not adequate as per NCTE Regulations.
- 2. Classroom size are not adequate as per NCTE Regulations. (387.50 Sq. ft which less than as per NCTE norms)
- 3. The institution has submitted notarized attested photocopy of site plan but the same is not approved by the competent authority.
- 4. The institution has submitted the list of faculty duly approved by the Registrar but has not submitted approval letter issued by the Registrar of concerned affiliating university.

Hence, the Committee decided to withdraw the recognition granted to Meppayur Salafi College of Education, P.O. Iringath, Pin 673523 Kozhikode District, Kerala for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to *Meppayur Salafi College of Education, P.O. Iringath, Pin 673523 Kozhikode District, Kerala* for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
