ORDER

WHEREAS, the institution namely **Meppayur Salafi College of Education, P.O. Iringath, Pin-673523, Kozhikode District, Kerala** was granted recognition vide SRC (NCTE) order no. F.KL/Sec/06/SRO/NCTE/2000-2001 dt. 06.11.2001 for conducting **B.Ed. Course** of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dt. 24.01.2015 consented to come under new Regulations.

3. **AND WHEREAS**, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt. 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic units of 50 students) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 17.07.2019

5. **AND WHEREAS**, the matter was further considered by the SRC in its 387th meeting held on 24th & 25th August 2020 and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 01.09.2020. The institution has submitted its reply against Final Show cause on 28.09.2020.

6. **AND WHEREAS**, the matter was further considered by the SRC in its 389th meeting held on 12th & 14th October, 2020 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 01.09.2020. The institution has submitted its reply on 23.09.2020. The Committee considered the reply and found the following deficiencies:-

1. *The Institution has submitted notarized attested photocopy of Building Plan the same is not approved by the competent authority. Multipurpose hall size is not adequate as per NCTE Regulations.*
2. *Classroom size are not adequate as per NCTE Regulations. (387.50 Sq. ft which less than as per NCTE norms)*
3. *The institution has submitted notarized attested photocopy of site plan but the same is not approved by the competent authority.*
4. *The institution has submitted the list of faculty duly approved by the Registrar but has not submitted approval letter issued by the Registrar of concerned affiliating university.*

Hence, the Committee decided to withdraw the recognition granted to Meppayur Salafi College of Education, P.O. Iringath, Pin 673523 Kozhikode District, Kerala for conducting B.Edcourse w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

7. AND WHEREAS, the Withdrawal Order was issued to the institution on 16.10.2020.

8. AND WHEREAS, the institution has submitted request for reconsideration reply received dated 26.10.2020 has been received from the Secretary Salafiyya Association Meppaur, Kerala.

9. AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on 28th -29th October, 2020 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*On the perusal of the reply submitted by the institution vide letter dt. 26.10.2020, the Committee decided that the **continuation order** be issued to the Institution **Meppayur Salafi College of Education, PO Iringath, Pin 673523 Kozhikode District, Kerala** for **B.Ed programme for 1 basic unit of 50 students**.*

10. NOW THEREFORE, this order is issued permitting the institution or continuation of conducting **Meppayur Salafi College of Education, P.B. No.1, P.O. Payyoli Angadi, Kozhikode (Dist.) Pin-673523 Kerala** Run by **Salafiyya Association, Meppayur** B.Ed. course of two years duration with an intake of 50 students (one basic units of 50 student) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution;
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter;
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
