Alappuzha District, Pin-690507, Kerala.vide SRC (NCTE) order No. F.KL/SEC/N/145/SRO/NCTE/2004-2005/753 dated 23.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 29.01.2015.
- AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic units) from the academic session 2015-2016.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance..
- AND WHEREAS, Accordingly, Show Cause Notice issued on 17.07.2019 The institution vide letter dated 02.08.2019 submitted reply to Show Cause Notice.
- AND WHEREAS, The matter was further considered by the SRC in its 387th meeting held on 24th & 25th August 2020 and the Committee decided to issue Final Show Cause Notice.
- AND WHEREAS, Accordingly, Final Show Cause Notice was issued on 01.09.2020 to reply within 21 days. The institution submitted its reply on 18.09.2020 & 01.10.2020.
- AND WHEREAS, the matter was further considered by the SRC in its 391^{th} meeting held on November 3rd, 2020 and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Buddha College of Education, Muthukulam North, Cheppad P.O. Alappuzha District, Pin-690507, Kerala for B.Ed programme for 1 basic unit of 50 students."

- NOW THEREFORE, this order is issued permitting the institution Buddha College of Education, Muthukulam North, Cheppad P.O. Survey No 445/4-3, 435/9, Alappuzha District, Pin-690507, Kerala for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfillment of the following conditions:
