WHEREAS, the recognition was granted to the institution namely, Titus II Teachers College, Tiruvalla, Pathanamthitta, Kerala for conducting B.Ed. course of one-year duration with an annual intake of 80 students vide SRC (NCTE) order No. SRO/NCTE/97-98/B.Ed./1891 dated 16.09.1997 subject to removal of certain deficiencies for the year 1997-1998.

- 2. WHEREAS, the institution submitted its compliance report with respect to removal of deficiencies on 24.11.1997, provisional Recognition was granted to the institution for conducting B.Ed. course of oneyear duration on 09.02.1998 subject to removal of certain deficiencies for the year 1998-1999.
- WHEREAS, the institution submitted its compliance report with respect to removal of deficiencies on 16.12.1998 and 29.03.1999 conditional Recognition was granted to the institution for conducting B.Ed. course of one-year duration on 09.06.1999 subject to removal of certain deficiencies for the year 1999-2000.
- WHEREAS, the institution submitted its compliance report with respect to removal of deficiencies on 29.12.1999. conditional Recognition was granted to the institution for conducting B.Ed. course of oneyear duration with an annual intake of 70 students on 22.03.2000 subject to fulfillment of certain conditions for the year 2000-2001.
- WHEREAS, the institution submitted its compliance report with respect to removal of deficiencies on 23.07.2001 & 26.07.2001, the institution had filed a court case in C.M.P. No. 28018/2000 and O.P. No. 17018/2000 in the Hon'ble High Court of Kerala challenging the teacher pupil ratio fixed by NCTE.
- 6. WHEREAS, a clarification letter in this regard was sent to the institution on 10.07.2002.
- WHEREAS, the institution submitted a copy of the interim direction of the Hon'ble High Court of Kerala in CMP No. 28018/2000 in OP. No 17018/2000 along with the staff list on 22.07.2012 allowing the petitioner institution to make admissions as per the student strength sanctioned by the University (150 students).
- AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution had submitted affidavit dated 29.01.2015 for its willingness for adherence of provision of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic unit of 50 students each) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 04.10.2019. in response, the institution submitted its written representation on 24.10.2019 but the institution has not submitted any documents which was asked for through Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 383rd meeting held on January 7-9, 2020 and the Committee decided to issue Final Show Cause Notice Accordingly, Final Show Cause Notice was issued on 21.01.2020, to reply within 21 days. And the institution submitted its reply on 10.02.2020.

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee decided to write a letter to the Institution asking therein to submit the following documents: -

- The institution is required to submit the LUC duly approved by the Competent Authority.
- 2) In NEC, survey no. & Re-Survey No. are not same, which is mentioned in Land Document.
- 3) In building plan, Site Area & built-up area are not mentioned by the institution.
- 4) Site Plan submitted by the institution is not approved by the competent authority.
- 5) In BCC, Date of inspection is not mentioned by the institution
- 6) The institution is required to submit the certified copy of registered land. .
- 7) The Institution has submitted Staff list which is not approved by the Registrar, Mahatma Gandhi University consisting of one principal, Nine Assistant and three part -time Lecturers against the requirement of 1+15 as per NCTE Norms. (For two basic units). The following part-time lecturers are: (FOR B.Ed.Course)
 - i. Mrs. Vyjayanthi P.S. (Performing Arts) from 04.02.2020.
 - ii. Samson P.S. (Fine Arts) from 04.02.2020.

- iii. Mrs. Anila Thomas (Physical Science Education) from 29.07.2019.
- Percentage of marks in PG degree in r/o Lecturers at S.No.6 & 7 is less than 55%.
- 8) The institution has submitted Staff list not approved by the Registrar, Mahatma Gandhi University consisting of one Principal and five Assistant professors against the requirement of 1+ 8 as per NCTE Norms. (For M.Ed. Course)
 - i. Percentage of marks in PG degree in r/o Lecturers at S.No.4 is less than 55%
 - ii. Lecturer at S.No.4 do not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017).
- 9) A letter dated 06.02.2020 issued by Deputy Registrar I (Academic), Mahatma Gandhi University that institution in the format prescribed by the NCTE for verification and approval of staff list by the Registrar and the same is under processing.
- 10) The institution is required to submit the latest staff list duly approved by the Registrar, affiliating university.
- 11) In 'Form A', FDR for Rs. 4.00 lakhs is in favour of NRC, NCTE.

In view of the above, the Committee decided to seek the above documents from the Institution by sending a last reminder (Letter) before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents / representation mentioned above within 21 days from the date of issue of the letter.

- 13. **AND WHEREAS**, as per decision taken in the meeting 387th, a Last Reminder was issued to the institution on 02.09.2020. In response, the institution submitted its reply on 17.09.2020 & 23.09.2020.
- 14. **AND WHEREAS,** the matter was further considered by the SRC in its 389th meeting held on October 12th & 14th, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 17.09.2020 & 23.09.2020, the Committee decided that the continuation order be issued to the Institution Titus II Teacher College, Tiruvalla-689101, Kerala for the following courses:-

- (i) B.Ed 1 unit of 50 students.
- (ii) M.Ed- 1 unit of 50 students.
- 15. NOW THEREFORE, this order is issued permitting the institution i.e. Titus II Teachers College, Tiruvalla, Pathanamthitta, Kerala run by Mar Thoma Syrian Church of Malabar, SCS Campus, Tiruvalla, Pathanamthitta, Kerala, for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfillment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 16. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 17. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 18. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The affidavit with enclosure submitted along with application. i.

The institution shall be free to post additional relevant information, if it so desires.

- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-19. date information on its official website.
- The institution shall make available the list of students admitted on its official website. 20.
- The institution shall fill the information on GIS Portal on the NCTE Website.If the institution 21. contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
