#### **CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, Christ College of Education for Women, No.102, A/4, 10 (parry Matriculation School Road), Mela Mettu Street, Vallam, Thanjavur District-613403, TamilNadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/16998 dt. 11.01.2008 for conducting Secondary B.Ed. Course of One year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 30.04.2015 and the revised provisional recognition order was issued to the institution on 25.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 351<sup>st</sup> meeting held on 28<sup>th</sup>& 29<sup>th</sup> Dec 2017 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 16.01.2018.
- 4. AND WHEREAS, the SRC in its 376<sup>th</sup> meeting held on 11<sup>th</sup> 12<sup>th</sup> June, 2019 has considered the matter and decided to withdraw the recognition. Accordingly, a Withdrawal Order was issued to the institution on 26.06.2019. The institution has filled a W.P.No. 14394/2019 challenging the decision taken by SRC in its 376<sup>th</sup> meeting. The Hon'ble High Court Vide order dated 15.07.2019 whereby directed the first respondent to take such a decision let the petitioner pay the inspection fee with specific writ request immediately within seven days from the date of receipt a copy of this order.
- 5. AND WHEREAS, the SRC in its  $379^{th}$  meeting held on  $21^{st} 22^{nd}$  August, 2019 has considered the matter and decided conduct inspection of the institution. Accordingly, as per the decision of SRC a letter was issued to the institution on 04.09.2019. The institution has submitted reply on 10.09.2019.
- 6. **AND WHEREAS,** the SRC in its 390<sup>th</sup> meeting held on 28<sup>th</sup> 29<sup>th</sup> Oct 2020 has considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 05.11.2020. The institution has submitted written representation on 17.11.2020.
- 7. **AND WHEREAS**, the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> February, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 08.03.2021. The institution has submitted reply received on 31.05.2021 and 05.07.2021.

- **8. AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> 12<sup>th</sup> August, 2021 considered the matter and decided to constitute VT for Shifting of premises. Accordingly, as per the decision of SRC inspection was conducted on 15.10.2021 & 16.10.2021 and VT report received on 25.10.2021.
- 9. AND WHEREAS, the SRC in its 404<sup>th</sup> meeting held on 16<sup>th</sup> & 17<sup>th</sup> November 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause was issued to the institution on 30.11.2021. The institution has submitted reply on 30.12.2021.
- **10. AND WHEREAS,** the SRC in its 406<sup>th</sup> Meeting held on 19<sup>th</sup> January, 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Christ College of Education for Women decided that shifting of premises be permitted to the institution at new address i.e. Old R-Survey No. 193/1, New TS No. 2 in Block-2 in Ward-8, Door No. 1626, Christ Bhawan, First Street, Rahuman Nagar, Medical College Road, Thanjavur District-613004, Tamilnadu.

Further, the Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each".

- 11. NOW THEREFORE, this order is issued permitting the institution i.e., Christ College of Education for Women to shift its premises at new address i.e. Old R-Survey No. 193/1, New TS No. 2 in Block-2 in Ward-8, Door No. 1626, Christ Bhawan, First Street, Rahuman Nagar, Medical College Road, Thanjavur District-613004, Tamilnadu with an order for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **12.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, guarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **15**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
