WHEREAS, Vidya Prachara Sangha, Pandavapur, Mandya, Karnataka submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Vijaya Teacher Training institute, Vidya Prachara Sangha, Pandavapura, Mandya District, Karnataka for Secondary (B.Ed) course of one year duration from the academic session 2004-05 with an annual intake of 100 students and was granted recognition on 03.12.2004.

AND WHEREAS, on 08.01.2010 the office received request letter for change of name from "Vijaya Teacher's Training College" to "Vijaya College of Education"

AND WHEREAS, the recognition was given in the name of "Vijaya Teacher Training Institute" and not "Vijaya Teacher's Training College". The institution submitted a copy of the resolution for change of name.

AND WHEREAS, the SRC in its 189th meeting held during 25th - 26th February, 2010 considered the request of the institution and decided to consider the change of name on receipt of Rs. 40,000/-. Accordingly, a letter was issued to the institution on 13.04.2010.

AND WHEREAS, a copy of the court notice cum interim order dated 27.01.2011 was forwarded by the NCTE, Hqrs to this office on 17.02.2011. Accordingly, a letter was addressed to the advocate, Sri. Ashok Haranahalli on 19.04.2011.

AND WHEREAS, an order dated 04.07.2011 was received by this office on 28.08.2012 from the Hon'ble High Court of Karnataka at Bangalore in W.P.No. 1755-1762/2011 and 2794-2975/2011(EDN-RES) filed by Sri. Vidya Teacher Training Institute, Pandavapur, Mandya and 9 others Vs. the State of Karnataka and others.

AND WHEREAS, on 20.01.2015, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students. As per the decision of SRC revised order was issued to the institution on 18.05.2015 with an intake of 100 students for two units of 50 students each. The institution submitted reply to the revised order on 03.08.2015

AND WHEREAS, request letter dated 30.09.2015 for running the B.Ed course with one unit of 50 students each was received from the institution on 01.10.2015. The SRC in its 292nd meeting held during 29th -30th September, 2015 considered the request of the institution and decided to "issue Corrections, as requested, in the detailing of number of basic units sanctioned."

AND WHEREAS, a Corrigendum was issued to the institution on 31.10.2015.

AND WHEREAS, the SRC in its 318th meeting held during 08th & 09th August, 2016 considered the request for change of college name and decided as under:-

- They want only one unit of B.Ed. The available built-up area is adequate for one unit. Fresh, inspection is not required.
- Change of name of College can be considered later ie., after the basic issue of Formal Recognition is decided.
