WHEREAS, the recognition was granted to the institution Rahmans College of Education, Jangaon Revenue Division, Hyderabad Road, Jangaon, Warangal Dist.-506167, Andhra Pradesh(Telangana) run by Rahmans Rural Awareness for Health and Mankind Society, Jangaon- 506167, Warangal Dist, Telangana vide SRC order No. F.AP/NEW/B.Ed/168/SRO/NCTE2003-2004/645 dt. 12.01.2004 for conducting B.Ed course of one-year duration with an annual intake of 100 students from the academic session 2003-2004.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has consented to come under new Regulations and has submitted notarized affidavit dated 13.01.2015. A Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC vide order no. F.SRO/ NCTE/APSO0309/B.Ed/ TS/2016-3. 17 dt. 01.06.2016 permitted the institution for shifting of premises to new location at Rahmans College of Education (APSO0309) & Rahmans Elementary Teacher Education Institutions (APSO2605), H.No. 3-13, Yeshwanthpura Village, Jangoan Mandal, Warangal Dist-506175, Telangana.
- AND WHEREAS, A reduction order vide order No. F.SRO/ NCTE/APSO0309/B.Ed/ TS/2016-17/89855 Dt. 12.11.2016 was issued to the institution from 2 units to 1 unit
- AND WHEREAS, the SRC in 381th meeting held on 31st October & 1st November, 5. decided to issue Show Cause Notice to all such institution where compliance/representation has not been submitted by the institution. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 19.11.2019. The institution vide letter dated 23.12.2019 submitted its reply along with the documents.
- AND WHEREAS, the SRC in its 384th meeting held on 12th & 13th February 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 26.02.2020. The institution vide letter dated 11.03.2020 submitted its reply along with the documents.

7. AND WHEREAS, the SRC in its 401st meeting held on 11th &12th August 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 11.03.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- The institution has submitted faculty list in which lecturer at S.No. 3, 5, 6, 7 does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. and The institution failed to appoint faculty for Fine Arts/ Performing Arts.
- 2. The institution has submitted photocopy of Building Completion Certificate but not approved by Competent Authority.
- 3. The institution has submitted photocopy only of Land Conversion Certificate and not submitted notarized/ attested copy Land Conversion Certificate.
- 4. The institution has submitted blue print of Building Plan in which two Multipurpose Hall size 25.9 x 32.3 and 25.9 x 32.3 both Multipurpose Hall size are less than 2000sqft. and demarcated area of D.El.Ed. Programme is not mentioned in Building Paln.
- 5. The institution has submitted "Form A" with photocopy FDRs Rs.5 lakhs and 3 lakhs. The institution is required to submit the details of FDRs for Endowment Fund & Reserve Fund of Rs. 12 lakhs.

Hence, the Committee decided to withdraw the recognition granted to Rahmans College of Education, H.No. 3-13, Yeshwanthpura Village, Jangoan Mandal, Warangal Dist-506175, Telangana for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rahmans College of Education, H.No. 3-13, Yeshwanthpura Village, Jangoan Mandal, Warangal Dist-506175, Telangana run by Rahmans Rural Awareness for Health and Mankind Society, Jangaon- 506167, Warangal Dist, Telangana for conducting B.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained

pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
