WHEREAS, the recognition was granted to the institution namely Vamsadhara Teacher Training College, Khasara No. 263/2, 264/7/, Plot No. 5-5-224, Main Road, Kotabommali, Srikakulam-532195, Andhra Pradesh for conducting D.El.Ed & D.El.Ed-Al course following teacher training courses:-

- The SRC vide Order No. SRCAPP1005/D.EI.Ed/AP/2013-14/51403 dated (i) 04.05.2013 for D.El.Ed. Course of two-years duration with an annual intake of 50 students from the academic session 2014-2015.
- The SRC vide order No. F.SRO/NCTE/SRCAPP15134/D.El.Ed-Al/AP/2016-(ii) 2017/83775 dated 11.04.2016 for conducting D.El.Ed-Al. Programme of two-years duration with an annual intake of 50 students (1 unit) from the academic session 2016-2017.
- AND WHEREAS, the management has submitted a letter on 30.12.2020 submission of closure of Institution.
- AND WHEREAS, The SRC in its 401st meeting held during 11th 12th August, 2021 3. considered the matter and decided as under;

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated30.12.2021by withdrawing the recognition granted to Vamsadhara Teacher Training College, Khasara No. 263/2, 264/7/, Plot No. 5-5-224, Main Road, Kotabommali, Srikakulam-532195, Andhra Pradesh for conducting D.El.Ed. alongwith additional intake Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course"
- NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Vamsadhara Teacher Training College, Khasara No. 263/2, 264/7/, Plot No. 5-5-224, Main Road, Kotabommali, Srikakulam-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
