**CONTINUATION ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Vivekananda College of Education, H.No. 7-1-10, Opp. Bus Stand, Adilabad -504 001, Andhra Pradesh** for conducting **B.Ed. & B.Ed.-AI course** following teacher training courses:-

- (i) The SRC vide order No. F.AP/B.Ed/92/SRO/NCTE/2000-2001/8333 dated 22.10.2001 for B.Ed. Course of one year duration from the academic session 2001-2002 with an annual intake of 120 students.
- (ii) The SRC vide order No. SRCAPP2702/B.Ed-AI/TS/2019/07067 dated 19.07.2019 for conducting B.Ed.-AI. (Additional Intake) for two-year duration with an additional intake of 50 students (one unit) from the academic session 2020-2021. Thus the total intake with the institution shall be 100 students (as per previous recognition orders + 50 students (as per this order) = 150 students (3 units) for the B.Ed. Programme of two years duration.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 1201.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct 01<sup>st</sup> Nov 2019 considered the matter and decided to issued SRC in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, First Show Cause Notice was issued on 25.11.2019. The institution has submitted its reply on 30.12.2019.

4. **AND WHEREAS**, the SRC in its 389<sup>th</sup> meeting held on 12<sup>th</sup> & 14<sup>th</sup> October 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued to the institution on 21.10.2020. The institution vide letter dated 07.11.2020 submitted its reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 399<sup>th</sup> meeting held on 15<sup>th</sup> -16<sup>th</sup> June 2021 has considered the matter and the Committee decided to last reminder (Letter). Accordingly, a Last Reminder Letter issued on 01.07.2021. The institution submitted vide letter received on 12.08.2021 its reply to the Last Reminder Letter.

6. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> August, 2021 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Vivekananda College of Education, Survey No. 53/1, Ramnagar Street Durganagar Road, Mavala, Adilabad Distirct-504001, Telangana for B.Ed. programme for 3 basic units of 50 students each”.*

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Vivekananda College of Education, Survey No. 53/1, Ramnagar Street Durganagar Road, Mavala, Adilabad Distirct-504001, Telangana** run by **C. Ram Reddy Memorial Educational Society, Ramnagar Durga Nagar Road, Village Mavala, Adilabad District-504001 Telangana** for continuation of recognition for **B.Ed. Programme** for two years duration (**3 basic units**) of **50 students each** subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;

- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
