WHEREAS, the recognition was granted to the institution namely Mercy College of Teacher Education "Dhanush" Edodi, Vatakara 673101 Kozhikode District Kerala vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/3850 dated 04.11.2005 (with conditions to shift to its own premises/Building within three years from the date of recognition) for conducting Secondary (B.Ed) of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 22.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05,2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the matter was placed before the SRC in its 367th meeting held on 21.12.2018 and the committee decided to issued Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 08.01.2019 and reply of Show Cause Notice received on 24.01.2019. The matter was further considered by SRC in its 380th meeting held on 18th -19th September 2019, and the committee decided that Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 26.09.2019 reply of Final Show Cause Notice received on 18.11.2019. The matter was further considered by SRC in its 383rd meeting held on 07th to 09th, November 2020, and the committee decided to Constitute the Visiting Team for inspection of infrastructure. Accordingly, a letter was issued to the institution on 15.01.2020 and reply of reply received on 05.06.2020. Thereafter, the inspection was conducted on 22nd & 23rd September 2020 and the report received on dt. 30.09.2020 with VT report.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on 15th to 16th, December 2020, and the committee decided to issue Show Cause Notice. Accordingly Show Cause Notice issue on 22.12.2020. The matter was further considered by the SRC in its 395th meeting held on 25th to 26th, February 2021 and the committee decided to issue final Show Cause Notice. Accordingly Final Show Cause Notice issue on 10.03.2021. The institution has submitted reply received in SRC as 24.02.2021 and 16.04.2021. The matter was considered by the SRC in its 399th Meeting held on 15th -16th June 2021 and the Committee decided to issue Last Reminder (Letter). Accordingly Last Reminder letter issued on 01.07.2021.

5. **AND WHEREAS,** the matter was placed before the SRC in its 401st meeting held on 11th & 12th August 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Mercy College of Teacher Educationdecided that shifting of premises be permitted to the institution at new address i.e. Re-survey No. 27/173, 27/174, Block No. 27, Ward No. VIII, Vatakara, Kozhikode District-673104, Kerala for B.Ed. programme for 2 basic units of 50 students each".

- 6. NOW THEREFORE, this order is issued permitting the institution i.e., Mercy College of Teacher Education "Dhanush" Edodi, Vatakara 673101 Kozhikode District Kerala to Shift its building at new address at Re-survey No. 27/173, 27/174, Block No. 27, Ward No. VIII, Vatakara, Kozhikode District-673104, Kerala run by Mercy Education Trust Established At "Dhanush" Edodi at Vatakara 673101 Kozhikode District Kerala Further as per decision of SRC, an order for continuation of recognition for B.Ed. Programme of two years duration with an intake of (2 basic units) of 50 students each Subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **8.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and

laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **10**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
