WHEREAS, the recognition was granted to the institution namely Enrich Christian College of Education, Marriguda, Nalgonda District, Pin-508245, Andhra Pradesh run by Enrich Christian Educational Society, Plot No. 29, Revenue Board Colony, Malakpet, Pin-500036, Hyderabad vide SRC (NCTE) order F.No.89-141/2003/Appeal/32010 dated 17.12.2003 for conducting B.Ed. Course of one-year duration from the academic session 2003-04 with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 29.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 03.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

**3. AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 01.03.2019. The institution has submitted reply to Show Cause Notice on 22.03.2019.

**4. AND WHEREAS**, the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on **15.11.2019**. The institution vide dated **30.11.2019** submitted reply in response to the Final Show Cause Notice.

**5. AND WHEREAS**, the matter was further considered by the SRC in its  $390^{\text{th}}$  meeting held on  $28^{\text{th}} - 29^{\text{th}}$  October, 2020 and the Committee decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS00270/B.Ed /TS/2020/20570-0576 dated 06.11.2020 was issued to the institution.

**6. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-286/E-171949/2020 Appeal/4<sup>th</sup> Mtg.-2021/21<sup>st</sup> January, 2021 dated 15.02.2021 appeal remand back the Order appealed against.

7. **AND WHEREAS**, the SRC in its  $395^{th}$  meeting held on  $25^{th} - 26^{th}$  February 2021 considered the matter and decided Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 15.03.2021. The institution has submitted reply of Final Show Cause Notice on 01.03.2021 & 01.04.2021

8. AND WHEREAS, the SRC in its 403<sup>rd</sup> meeting held on 18<sup>th</sup> -19<sup>th</sup> October, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Enrich Christian College of Education, Survey No. 309/A2, Beside Police Station Marriguda, Marriguda Nalgonda District-508245, Telangana for B.Ed. programme for 2 basic units of 50 students each."

9. NOW THEREFORE, this order is issued permitting the institution i.e. Enrich Christian College of Education, Survey No. 309/A2, Beside Police Station Marriguda, Marriguda Nalgonda District-508245, Telangana run by Enrich Christian Educational Society, Plot No. 29, Revenue Board Colony, Malakpet, Pin-500036, Hyderabad Telangana for continuation of recognition for B.Ed. Programme for two years duration (2 basic units) of 50 students each subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

**10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

**11.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

a. Sanctioned programme(s) along with annual intake in the institution:

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
   k. Any false or incomplete information on website shall.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

**13**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
