WHEREAS, the recognition was granted to the institution Anantha Sevashramna Vishwastha Samithi, Malladihalli, Holalkere Taluk, Chitraduraga District, Karnataka-577531 run by Ananthasevashrama Trust, Malladihalli, Holalkere Taluk, Chitradurga District, Karnataka-577531 vide SRC order No. F.SRO/NCTE/B.Ed./2004-2005/8911 on 30.11.2004 for conducting secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit on 08.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- WHEREAS. corrigendum F.No.SRO/NCTE/APS02412/B.Ed./KA/2015-2016/68987 dt. 30.06.2015 was issued for conducting B.ED. Programme of two years duration with an annual intake of 50 students (one unit) from the academic session.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the 4. matter and decided to issue Show Cause Notice to all such institution which have not submitted compliance. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 13.03.2019. The institution did not submit any reply for Show Cause Notice.
- AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 5. considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 01.12.2020. The institution vide letter dated 21.12.2020 has submitted reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 400th Meeting held on 13th & 14th July 2021 the matter was considered and decided to issue Last Reminder (Letter) to the institution. Accordingly, as per decision of SRC Last Reminder (Letter) was issued to the institution on 02.08.2021. The institution has submitted its reply on 05.08.2021.
- AND WHEREAS, the SRC in its 403rd Meeting held on 18th & 19th October, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Anantha Sevashramna Vishwastha Samithi, Survey No. 9/1,2,3,4, Malladihalli, Holalkere Taluk, Chitradurga District-577531, Karnataka for B.Ed. programme for 1 basic unit of 50 students."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., Anantha Sevashramna Vishwastha Samithi, Survey No. 9/1,2,3,4, Malladihalli, Holalkere Taluk, Chitradurga District-577531, Karnataka run by Ananthasevashrama Trust, Malladihalli, Holalkere Taluk, Chitradurga District, Karnataka-577531 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
