CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution **Christ College of Education, Hosur Road, Bangalore, Karnataka-560029** run by **Christ Educational Society, Bangalore, Karnataka** vide SRC order No. F.SRO/NCTE/B.Ed./2005-2006/4856 on 21.12.2005 for conducting secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 20.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 20.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. AND WHEREAS, a Corrigendum was issued vide order no. F.SRO/NCTE/APS03519/B.Ed./KA/2016/89489 dt. 02.11.2016 the name of the institution may be read as **School of Education, Christ University, Hosur Road, Bangalore, Karnataka-560029** in place of **Christ College of Education, Hosur Road, Bangalore, Karnataka-560029.**

4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 26.04.2019. The institution did not submit any reply to Show Cause Notice.

5. AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Final Show Cause Notice to all the institutions wherein Recognition was accorded by the SRC with the direction to submit all requisite documents. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 21.10.2020. The institution has submitted its reply on 02.02.2021.

6. AND WHEREAS, the SRC in its 396th meeting held on 03rd March 2021 considered the matter and decided to issue Withdrawal order. Accordingly, as per decision of SRC Withdrawal Order vide order no. F.SRO/NCTE/APS03519/B.Ed./KA/2021/124996-5003 was issued to the institution on dated 15.03.2021.



7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. File No.89-168/E-185634/2021 Appeal/15th Meeting, 2021 Appeal No. APPLSRC202114034 dated 30.06.2021 appeal remand back the order appealed against. The institution did not submit any reply to the Appeal Remand Back Order.

8. **AND WHEREAS**, the SRC in its 401st Meeting held on 11th & 12th August 2021 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 31.08.2021. The institution has submitted its reply on 07.10.2021.

9. **AND WHEREAS**, the SRC in its 403rd Meeting held on 18th & 19th October, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee on perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Christ College of Education, Survey No. 75, Hosur Road, Bangalore-560029, Karnataka for B.Ed. programme for 2 basic units of 50 students each.**"*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e., **School of Education, Christ University, Hosur Road, Bangalore, Karnataka-560029** run by **Christ Educational Society, Bangalore, Karnataka** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
