WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Vivekananda College of Education, Agasteeswaram Village & Post, Agasteeswaram Taluk, Kanyakumari, Tamilnadu-629701 run by Vivekananda Educational Society, Agasteeswaram, Kanyakumari District, TamilNadu vide order No. F.SRO/NCTE /B.Ed./2008/5049 dated 22.09.2008 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 21.01.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 18.03.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 the matter was considered and decided to issue Show Cause Notice to the institution in compliance of RPRO. Accordingly, as per decision of SRC Show Cause Notice dated 08.06.2021 was issued to the institution. The institution has not submitted reply of show cause notice.
- **4. AND WHEREAS,** the SRC in its 405^{th} meeting held on $13^{th}-14^{th}$ December 2021 has considered the matter and decided to issue a Final Show Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice dated 29.12.2021 was issued to the institution. The institution has submitted reply received on 31.12.2021.
- **5. AND WHEREAS,** the SRC in its 408th meeting held on 02nd March 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS09086/B.Ed./TN/2022/130917-130921 dated 15.03.2022 was issued to the institution.
- 6. AND WHEREAS, an Order passed by Hon'ble High Court of Delhi Order dated 06.10.2022 in W.P. (C) No.14152/2022 & CM APPL.43208/2022. In compliance of Hon'ble High Court, an order of SRC dated 19.10.2022 regarding entitlement to participate the counselling for the academic session 2022-2023.
- **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-129/E-253776/2022 Appeal/7th Meeting, 2022 Appeal No.APPLSRC202214327 dated 19.10.2022

- **8. AND WHEREAS,** the SRC in its 415th meeting held on 3rd 4th November 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision, a Final Show Cause Notice dated 22.11.2022 was issued to the institution. As per decision uploaded in NCTE website, the institution has submitted a reply to the final Show Cause Notice on 14.11.2022.
- 9. AND WHEREAS, the SRC in its 419th meeting held on 13th January 2023 was considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a last reminder letter was issued to the institution on 27.01.2023. The institution has submitted a reply to the last reminder letter on 02.02.2023.
- 10. AND WHEREAS, the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Vivekananda College of Education, D. No. 5/183-1,2, (Block-A), Re-survey No. 189/2, 188/7, Agasteeswaram Village, Agasteeswaram Town Panchayat & Taluk, Kanyakumari, Tamilnadu-629701 for B.Ed. programme for 2 basic units of 50 students each."

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. Vivekananda College of Education, D. No. 5/183-1,2, (Block-A), Re-survey No. 189/2, 188/7, Agasteeswaram Village, Agasteeswaram Town Panchayat & Taluk, Kanyakumari, Tamilnadu-629701 for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic unit) of 50 students each subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **13.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **15.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
