ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Regional Institute of Education, Manasagangotri, Mysore-570006, Karnataka has by affidavit dated 24.04.2017 consented to come under New Regulations and sought for two basic units in B.Ed. which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has to submit all relevant documents and prepare for causing VT inspection.
- **4. AND WHEREAS,** it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents within 31.03.2018.
- (ii) The applicant-institution will be required to submit the following documents within 31.03.2018 such as
 - 1. Certified copy of Land document of the building/ location for having own land in the name of the institution/Society/Trust.
 - 2. Blue print of Building plan of the new building duly approved by the Government Authority.
 - 3. Building Completion Certificate in original from the Government authorities in the prescribed format (format enclosed).
 - Notarized copy of Land usage certificate from the concerned Government authorities stating that the land is exclusively permitted / sanctioned for educational purposes only
 - 5. Encumbrance certificate in original from the competent Government.
 - 6. Original Fixed deposit receipt of Rs. 5.00 lakhs kept in Joint Account with SRC in any of the scheduled bank for a period of 5 years towards Endowment fund in original
 - 7. Original Fixed deposit receipt of Rs. 7.00 lakhs kept in Joint Account with SRC in any of the scheduled bank for a period of 5 years towards Reserve fund in original

9. The University is required to submit staff profile duly signed by the

competent authority as per NCTE norms.

10. The University is required to submit staff salary particulars and bank statements.



- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions before 31.03.2018. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2018-2019.
- 5. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Regional Institute of Education, Manasagangotri, Mysore-570006, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2017-18 subject to fulfilment of the conditions mentioned herein within 31.03.2018.
- **6.** Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

e) Name of faculty members who left or joined during the last, quarter:

- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
