WITHDRAWAL ORDER

WHEREAS, recognition u/s14 (1) of NCTE Act, 1993 was granted to the institution namely, Venkata Sai Diploma in Elementary Education Institution, Khasara No.533/A, 534/A, 534/E, Plot No.1115, 2907, Street No.10-135/1, Devarakadra Village and Post, atmakur Taluk, Devarakadra City Mahbubnagar District-509204, Telangana run by Venkata Sai Educational Society, No.10-135/1, Devarakadra Village and Post, atmakur Taluk, Devarakadra City Mahbubnagar District-509204, Telangana vide SRC (NCTE) order no. F.No.SRCAPP880 /D.El.Ed./AP/2012/44942 dated 03.08.2012 for conducting D.El.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2012-2013.

2. AND WHEREAS, letter has been received from the management of the institution on 07.09.2022 for closure of D.El.Ed. Programme.

3. AND WHEREAS, the SRC in its 414th Meeting of SRC held on 26th – 27th September 2022 considered the matter for closure of the D.El.Ed. Programme and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution on 07.09.2022 by withdrawing the recognition granted to Venkata Sai Diploma in Elementary Education Institution, Khasara No.533/A, 534/A, 534/E, Plot No.1115, 2907, Street No.10-135/1, Devarakadra Village and Post, atmakur Taluk, Devarakadra City Mahbubnagar District-509204, Telangana for conducting D.El.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **Venkata Sai Diploma in Elementary**

Education Institution, Khasara No.533/A, 534/A, 534/E, Plot No.1115, 2907, Street No.10-135/1, Devarakadra Village and Post, atmakur Taluk, Devarakadra City Mahbubnagar District-509204, Telangana run by Venkata Sai Educational Society, No.10-135/1, Devarakadra Village and Post, atmakur Taluk, Devarakadra City Mahbubnagar District-509204, Telangana for conducting D.El.Ed. Programme of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
