WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 (1) of NCTE Act, 1993 was granted to the institution namely, Irudaya Andavar Teacher Training Institute, No.45, Krauppur, Muarudhanallur Post, Kumbakonam Taluk, Thanjavur District-612402, TamilNadu for D.T.Ed.& D.T.Ed.-AI programme as per following details:-

- (i) Vide Order No.F.TN-ELE/589/SRO/NCTE/2004-05/1120 dated 22.09.2004 to offer D.T.Ed. Elementary course of two-year duration with an annual intake of 50 students from the academic session 2004-2005.
- (ii) Vide order No.F.SRO/NCTE/D.T.Ed.-A.I./2006-2007/17795 dated 08.02.2008 for conducting D.T.Ed. (Additional Intake) course of two-years duration with an annual intake of 50 students.

2. AND WHEREAS, a request letter dated has been received from the institution on 02.09.2022 requesting for closure.

3. AND WHEREAS, the SRC in its 414th Meeting of SRC held on 26th – 27th September 2022 considered the matter request for closure and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 02.09.2022 by withdrawing the recognition granted to Irudaya Andavar Teacher Training Institute, No.45, Krauppur, Muarudhanallur Post, Kumbakonam Taluk, Thanjavur District-612402, TamilNadu for conducting D.T.Ed, D.T.Ed.-AI Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Irudaya Andavar Teacher Training Institute, No.45, Krauppur, Muarudhanallur Post, Kumbakonam Taluk, Thanjavur District-612402, TamilNadu run by Integrated Multi-Service Trust, Thanjavur District-

612402, TamilNadu for conducting **D.T.Ed., D.T.Ed.-A.I. Programme** of two years duration with an annual intake of **50 + 50 students** with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
