ORDER

WHEREAS, recognition was granted to the institution namely Sree Dattha Brindavan Institute of Teachers Education, Plot/Khasara No.Sy.No.54, Plot No.Sy.No.54 PART Singaram X Street, KavarampallySivar Village, Narayanpet Post & Taluk, Mahabubnagar City, Mahabubnagar District – 509210, Telangana run by Vyjayanthi Educational Society, Plot No.Sy 54 PART, Singaram X Roads, KavarampallySivar Village, Narayanpet Post, Mahabubnagar Taluk & City, Mahabubnagar District – 509210, Telangana vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP14884/B.Sc.B.Ed/TS/2019/103830-3836 dt. 26.04.2019 for conducting B.Sc.B.Ed course of four-year duration with an annual intake of 100 students from the academic session 2020-21.

AND WHEREAS, the institution filed a Writ Petition No.588/2019 before the Hon'ble Supreme Court of India with a prayer to issue FR for the academic year 2019-20 as the ongoing counseling and admission process was not commenced in the State of Telangana. The Hon'ble Supreme Court vide order dated 19.07.2019 directed as follows:-

"...We direct that recognition by National Council for Teacher Education (respondent No.1) and affiliation by the concerned University be granted so far as the B.Sc.B.Ed Course of the petitioner – Institution is concerned for the academic year 2019-2020.

The writ petition stands disposed of.

AND WHEREAS, the SRC in its 379th meeting held on 21st – 22nd August, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) In obedience to the Hon'ble Supreme Court Orders the SRC resolved to revise the year of session mentioned in the SRC Order No. SRO/NCTE/SRCAPP 14884/B.Sc.B.Ed/TS/2019/103830-3836 dated 26.4.2019 as 2019-2020 instead of 2020-2021.

Accordingly, directed the SRC office for issuance of amended orders.

NOW THEREFORE, as per the orders of the Hon'ble Supreme Court the recognition of the institution granted to Sree Dattha Brindavan Institute of Teachers Education, Plot/Khasara No.Sy.No.54, Plot No.Sy.No.54 PART Singaram X Street, Kavarampally Sivar Village, Narayanpet Post & Taluk, Mahabubnagar City, Mahabubnagar District – 509210, Telangana

run by Vyjayanthi Educational Society, Plot No.Sy 54 PART, Singaram X Roads, Kavarampally Sivar Village, Narayanpet Post, Mahabubnagar Taluk & City, Mahbubnagar District – 509210, Telangana for conducting B.Sc.B.Ed course for four year duration with an intake of 100 students (2 units) shall be effective from the academic session 2019-20 instead of 2020-21 mentioned in SRC Order No. SRO/NCTE/SRCAPP 14884/B.Sc.B.Ed/TS/2019/103830-3836 dated 26.4.2019. The SRC order is accordingly modified.

Other terms & conditions mentioned in SRC Order No. SRO/NCTE/SRCAPP 14884/B.Sc.B.Ed/TS/2019/103830-3836 dated 26.4.2019 shall remains the same.
