WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, Ramakrishna Institute of Moral and Spiritual Education, Yadavagiri, Mysore, Karnataka-570020 vide SRC vide order no. F.KR/SE/32/SRO/NCTE/2000-2001/681 dt. 04.07.2000 for two semester B.Ed. course (RIMSE Scheme) of one year duration form the academic session 2000-2001 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, a corrigendum order no. F.SRO/NCTE/AOSO0409/B.Ed./KA/2015/70713 dt. 23.07.2015 was issued for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22<sup>nd</sup> Oct 2019. The Sub-Committee noted that the institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN to all such institutions. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 30.10.2019.
- 4. AND WHEREAS, the institution has submitted a written representation on 08.11.2019 as under:-

"As you already know, Ramakrishna Institute of Moral & Spiritual Education (RIMSE), Mysuru, Karnataka is a unit of Ramkrishna Ashrama, Mysuru which is a branch of the well-known Ramakrishna Math and Ramakrishna Mission, Belur Math, West Bengal.

Due to mushrooming of hundreds of B.Ed. colleges in many states and opening of other job opportunities in fields like IT, ITES etc., the number of students opting teaching profession has reduced considerably. This has severely affected the admissions to B.Ed. course at RIMSE.

We would like to inform you, that there was a very less inflow of students since 2008. Previous year also (2018-2019) no student was there for B.Ed. admission. We waited for one more year and closed our institute from the academic year 2019-20. This we have already informed you vide our letter at Ref. (3). We had also attached a copy of the letter addressed to The Registrar, University of Mysore to issue a No objection Certificate

(NOC). Even after several follow-ups we are yet to obtain NOC from the Mysore University. Once we get the same, we will forward a copy to yourself.

We have submitted all the documents as per point 6 of your letter at Ref. (1) of our Institute. The scanned copies of the documents are also uploaded and submitted on the website.

As we have already submitted all the documents online and sent the hard copies during the running of the Institute and also now the status of the Institute stands as closed, we request you to kindly verify your records.

We hope this intimation well satisfy your requirements and we look forward for the confirmation of the same in this regard."

5. AND WHEREAS, the SRC in its 412<sup>th</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> July, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Management vide letter dated 08.11.2019 by withdrawing the recognition granted to Ramakrishna Institute of Moral and Spiritual Education, Yadavagiri, Mysuru, Karnataka-570020 for conducting B.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to Ramakrishna Institute of Moral and Spiritual Education, Yadavagiri, Mysuru, Karnataka-570020 run by Sri Ramakrishna Ashrama, Yadavagiri, Mysuru, Karnataka-570020 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails

or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
