AND WHEREAS, the recognition was granted to the institution namely, Majmaa Training College, Rahmath Nagar, P.O. Kavanurm Areacode, Malappuram District, Pin-673644, Kerala run by Majmaa Training Al- Islami, Rahmath Nagar, P.O. Kavanur, Areacode, Malappuram District, Pin-673644, Kerala vide SRC (NCTE) order No.F.KL/SEC/N/231/SRO/NCTE/2004-2005/791 dated 23.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- **2. AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations.
- 3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 17.07.2019. In response, the institution submitted its written representation on 23.09.2019.
- **5. AND WHEREAS,** the matter was further considered by the SRC in its 387th Meeting held on August 24th & 25th, 2020 and the Committee decided as follows:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the Show Cause Notice's reply submitted by the institution on 25.09.2019 & 01.10.2019 and found the following deficiencies: -

- 1. CLU has not submitted by the institution duly approved by the competent authority.
- 2. A Notarized copy of NEC not submitted by the institution duly approved by the competent authority.
- 3. The building plan submitted by the institution was not approved by the competent authority in which built-up area and site area are not mentioned in the document.

- 4. A notarized copy of Building Completion Certificate has not submitted by the institution.
- 5. The institution has not submitted certified copy of registered land.
- 6. Original Staff list approved by the Registrar consisting of one principal & Eight Assistant Professor submitted on 26.07.2019. The deficiencies in staff list are as below: -
 - Lecturer at S.No.4, 5 & 8 do not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. The Staff details are as follows:
 - a. Jayadevan E works as an Assistant Professor in Philosophy appointed on 01.06.2018.
 - b. Linto Devaraj works as an Assistant Professor in Physical Education appointed on 01.12.2018.
 - c. Ajeesh PP works as an Assistant Professor in English appointed on 12.07.2018.
 - Lecturer at S.No.6, percentage of marks in PG Degree is less than 55%.
 - Lecturer at S.No.5, does not have the qualification of PostGraduation.
- 7. The institution has submitted Form "A" issued by the Branch Manager with the photocopy of two Matured FDRs in favour of NCTE. The institution is required to submit the renewed FDRs along with Form A.
- 8. At the time of Recognition, building plan documents are differ from the latest document submitted on 11.09.2019.

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice**.

- 6. AND WHEREAS, as per decision taken in the meeting 387th, a Final Show Cause was issued to the institution on 01.09.2020. In response, the institution submitted its reply on 21.09.2020.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 389th meeting held on October 12th & 14th, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 01.09.2020. The institution has submitted its reply on 21.09.2020. The Committee considered the reply and found the following deficiencies: -

- 1. The institution has not submitted original blueprint of building Plan duly approved by the competent authority.
- 2. The institution has submitted Photocopy of Notarized Building plan but is not showing the area of Multipurpose hall and library However, the size multipurpose hall 1227.83 sq.ft. (1870x610) and Class Rooms which are less than the requirement as per NCTE norms.
- 3. The institution has submitted Photocopy of Faculty list duly approved by Registrar University of Calicut, but approval letter issued by the university has not been submitted.
- 4. The institution has not appointed faculty for Fine Arts & performing arts.
- 5. The institution has not submitted certificates of educational qualifications of the faculty.

Hence, the Committee decided to withdraw the recognition granted to Majmaa Training College, Rahmath Nagar, P.O. Kavanurm Areacode, Malappuram District, Pin- 673644, Kerala for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to *Majmaa Training College, Rahmath Nagar, P.O. Kavanurm Areacode, Malappuram District, Pin-673644, Kerala* for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
