AND WHEREAS, the recognition was granted to the institution namely, Jamia Training College, Chithara P.O., Kadakkal, Kollam District – 691559, Keral vide SRC (NCTE) order No F.KL/SRO/NCTE/2007-2008/15390 dated 30.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

- **2. AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated **27.01.2015** for its willingness for adherence of provisions of new Regulations.
- 3. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (One basic units) from the academic session 2015-2016.
- 4. AND WHEREAS, the request of the institution was placed before SRC in its 369rd meeting held on 28.01.2019 and the committee considered the matter and decided to issue Show Cause notice be issued to all such institution which have not submitted by the institution. Accordingly, First Show Cause Notice issued on 22.07.2019 to reply with 30 days till date.
- 5. AND WHEREAS, the request of the institution was placed before SRC in its 380th meeting held on 18-19 September 2019. The committee considered the matter and decided to Final Show Cause Notice be issued to all such institution.
- a **Final Show Cause Notice** issued to the institution on **31.10.2019**. The institution submitted its reply vide letter dt 22.11.2019 received on **29.11.2019**.
- **6. AND WHEREAS,** the matter was further considered by the SRC in its 389^{th} meeting held on October 12^{th} & 14^{th} , 2020 and the Committee decided as follows: --

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
