## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

AND WHEREAS, the recognition was granted to the institution namely, Sahodaran Ayyappan Memorial Training College, Poothotta P.O., Pin- 682307, Ernakulam District, Kerala vide SRC (NCTE) order No F.KL/SEC/SRO/NCTE/2006-2007/6615 dated 28.08.2006 for conducting M.Ed. course of one-year duration with an annual intake of 25 students from the academic session 2006-2007.

- 2. AND WHREAS, enhancement of intake of 10 seats from existing 25 to 35 was permitted to Sahodaran Ayyappan Memorial Training College, Poothotta P.O., Pin-682307, Ernakulam District, Kerala for M.Ed. course w.e.f. the session 2010-2011 till further without creation of any infrastructural and instructional facilities vide order dated 20.08.2010.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations.
- 4. AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 07.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one basic units) from the academic session 2015-2016.
- **5. AND WHEREAS,** the request of the institution was placed before SRC in its 369<sup>rd</sup> meeting held on 28.01.2019 and the committee considered the matter and decided to issue Show Cause notice be issued to all such institution which have not submitted by the institution. Accordingly, **First Show Cause Notice** issued on 22.07.2019 and the institution has submitted reply of Show Cause notice dated 11.09.2019
- 6. AND WHEREAS, the request of the institution was placed before SRC in its 383<sup>th</sup> meeting held on 7-9 January, 2020. The committee considered the matter and decided to Final Show Cause Notice be issued to all such institution. Accordingly, a Final Show Cause Notice issued to the institution on 22.01.2020 and the institution has submitted reply of Final Show Cause notice dated 18.02.2020.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 386<sup>th</sup> meeting held on July 23<sup>th</sup> & 24<sup>th</sup>, 2020 and the Committee decided to issue Last reminder letter Accordingly, Last Reminder letter issued to the institution on 07.08.2020 and the institution has submitted reply of reminder letter on 22.09.2020.
- 8. **AND WHEREAS,** the matter was further considered by the SRC in its 389<sup>th</sup> meeting held on October 12<sup>th</sup> & 14<sup>th</sup>, 2020 and the Committee decided as follows: --

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee decided to withdraw the recognition granted to Sahodaran Ayyappan Memorial Training College, Poothotta P.o., Pin-682307, Ernakulam District, Kerala for conducting M.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 14.09.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course

- 9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sahodaran Ayyappan Memorial Training College, Poothotta P.o., Pin-682307, Ernakulam District, Kerala for conducting M.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- **10.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
