WITHDRAWAL ORDER**

AND WHEREAS, the recognition was granted to the institution **Immaculate Teacher Training Institute, Pillatheruvasai, Nedumgadu -609603, Karaikal District, Pondicherry.** vide SRC (NCTE) order No F.PN-N/04/SRO/NCTE/2000-01/1265 dt. **19.07.2000** for conducting **Elementary Course** of one-year duration with an annual intake of **50** students from the academic session **2000-2001**.

2. AND WHEREAS, the matter was placed before the SRC in its **181st meeting held on 20-21 August, 2009** a SCN was issued to institution completion of Building dated **24.09.2009**. The institution did not submitted reply to Show Cause Notice.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its **381st meeting held on 31st October-01st November 2019** and the committee decided issue Show Cause Notice.

4. AND WHEREAS, accordingly, **Final Show Cause Notice was issued on 02.09.2020** to reply within 30 days. The institution has not submitted reply of show cause notice.

5. AND WHEREAS, the matter was further considered by the SRC in its **392th meeting held on 15th - 16th December, 2020** and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution has failed to submit reply / written representation in respect to the Show Cause Notice dt 02.09.2020 issued to the institution.

*Hence, the Committee decided to **withdraw the recognition granted to The Immaculate of Heart of Mary Society, Society No. 1(Pondicherry) Immaculate Heart of Mary's Convent, St. Therese Street, Pondicherry-605001 for conducting Elementary, courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.**"*

6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to to **Immaculate Teacher Training Institute, Pillatheruvasai, Nedumgadu -609603, Karaikal District, Pondicherry for Elementary Course** of two years duration with an annual intake of **50** students w.e.f. the next academic session.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
