WITHDRAWAL ORDER**

AND WHEREAS, the recognition was granted to the institution namely **Vinayaka Missions College of Education, Pondicherry-Cuddalore Main Road, Kirumambakkam Village, Pondicherry-607402** run by **Vinayaka Mission's Research Foundation, Deemed University, NH-47, Sankari Main Road, Ariyanoor, Salem-636308, Tamilnadu**, vide SRC (NCTE) order No. F.PN-N/20/SRO/NCTE/2005-06/2357 dated **12.08.2005** for conducting **Secondary (B.Ed.) course** of one-year duration with an annual intake of **100** students from the academic session **2005-2006**.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated **23.01.2015**.

3. AND WHEREAS, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt.31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.

4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 02.05.2019. The institution submitted its reply on 24.05.2019.

5. AND WHEREAS, SRC in its 387th meeting held on 24th- 25th August 2020 decided sending a Final Show Cause Notice. Accordingly, Letter was issued on 01.09.2020. The institution has not submitted any compliance against Final Show Cause Notice.

6. AND WHEREAS, the matter was further considered by the SRC in its 393rd meeting held on 05th -06th January 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The institution has not responded to the Final Show Cause Notice issued on 01.09.2020.**

*Hence, the Committee decided to **withdraw the recognition** granted to **Vinayaka Missions College of Education, Pondicherry-Cuddalore Main Road, Kirumambakkam Village, Pondicherry-607402** for conducting **B.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.*

7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Vinayaka Missions College of Education, Pondicherry-Cuddalore Main Road, Kirumambakkam Village, Pondicherry-607402** for **B.Ed.** course of two years duration with an annual intake of 100 students w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
