ORDER

WHEREAS, the recognition was granted to the institution namely, **Mahatma Gandhi University College of Teacher Education, Elanthoor Post, Pathanamthitta District-689643, Kerala** vide SRC (NCTE) order No. F.KL/F.SRO/NCTE/B.Ed./2007-2008/13902 dated **01.11.2007** for conducting **B.Ed.** course of one-year duration with an annual intake of **100** students from the academic session 2007-2008.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated **17.06.2015**.

3. AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on **30.06.2015** for conducting **B.Ed.** course of two years duration with an annual intake of **50** students (**one basic units**) from the academic session **2015-2016**.

4. AND WHEREAS, the matter was further considered by the SRC in its 369th meeting held on **21.08.2019** and the Committee decided to issue Show Cause Notice. accordingly, Show Cause Notice issued on **17.07.2019**. to reply within 21 days. The institution reply received on **21.08.2019** submitted reply to Show Cause Notice.

5. AND WHEREAS, the matter was further considered by the SRC in its 388th meeting held on September 14th -15th, 2020 Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act, 1993** before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice**.

6. AND WHEREAS, accordingly, Final Show Cause Notice issued on **24.09.2020** to reply within 21 days. The institution reply received on **28.09.2020** & **24.11.2020** submitted reply to Show Cause Notice.

7. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 389th meeting held on 08th - 09th October.2020 and the committee decided that Last Reminder letter issued to the Institution. Last Reminder letter issued on **19.10.2020**.

8. AND WHEREAS, reply of Final Show Cause Notice on **24.11.2020.**

9. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 393th meeting held on 05th - 06th January 2021 and the committee decided as follows:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Mahatma Gandhi University College of Teacher Education, Elanthoor Post, Pathanamthitta District 689643, Kerala** for B.Ed programme for **1 basic unit of 50 students.***

10. NOW THEREFORE, this order is issued permitting the institution **Mahatma Gandhi University College of Teacher Education, Sy. No. 190/10 Ward Number X Elanthoor Post, Pathanamthitta District 689643, Kerala** for B.Ed. course of two years duration with an annual intake of **50 students (one basic units)** subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self - Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
