CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely **Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi- 590010, Karnataka** vide SRC NCTE order No. F.KAR/B.Ed/27/SRO/NCTE/2000-2001/1241 dated 18.07.2000 for B.Ed. course of one-year duration from the academic session 2000-2001 with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 23.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. courses of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 381st meeting decided to issue Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 06.11.2019. The institution vide letter dated 26.11.2019 submitted its reply to the show cause notice along with the documents.

4. AND WHEREAS, the above reply was placed before the SRC in its 383rd meeting held on 07th – 09th January 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to the institution to submit the representation to the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued to the institution on 16.01.2020. The institution has submitted its reply along with the following documents on 06.02.2020.

5. AND WHEREAS, the above matter was placed before the SRC in its 393rd meeting held on 5th-6th January 2021. The Committee considered the matter and decided to issue withdraw the recognition. Accordingly withdraw order was issued to institution vide order No. F.SRC/NCTE/APS03351/B.Ed./KA/2021/123107-3113 dated 19.01.2021.

6. AND WHEREAS, the SRC in the light of the fact that the Institution submitted its reply prior to withdrawal of recognition on 11.11.2020, therefore, reconsidered the matter in its 397th meeting held on 25th – 26th March, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-



The Committee noted that the institution had submitted its reply on 11.11.2020, however the same could not be considered. In view of the above the Committee reconsidered the matter and decided to cancel the Withdrawal Order dated 19.1.2021.

The Committee on the perusal of the reply submitted by the institution dated 11.11.2020 decided that the **continuation order** be issued to the Institution **Krantiveer Sangolli Rayanna College of Education, CTS.1067, Nehrunagar, Belagavi- 590010, Karnataka** for **B.Ed. programme for 2 basic units of 100 students**. Accordingly a revised speaking continuation order be issued.

7. NOW THEREFORE, this order is issued permitting the institution i.e. **Krantiveer Sangolli Rayanna College of Education, CTS.1067, Nehrunagar, Belagavi- 590010, Karnataka** run by **Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi- 590010, Karnataka** for continuation of recognition for B.Ed. course for two years duration (**2 basic units**) of 100 students subject to fulfilment of the following conditions:


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:



- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.


13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

The Withdrawal Order No. F.SRC/NCTE/APS03351/B.Ed./KA/2021/123107-3113 dated 19.1.2021 stands cancelled.

Also order that a copy of this Order be published in the official Gazette.
