#### WITHDRAWAL ORDER

WHEREAS, Aryan B.Ed College, No. 147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga - 585105, Karnataka was granted recognition for offering B.Ed course on 05.01.2005 with an intake of 100 students.

AND WHEREAS, a shifting order was issued to the institution vide order no. F.No.APSO2315-B.Ed/KA/2011/33409 on 08.12.2011 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units).

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure), Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014. On promulgation of NCTE Regulations, 2014, the institution submitted affidavit dt 10.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution vide order no. F.SRO/NCTE/APSO2315/B.Ed/KA/2014-15/64945 on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, show cause notice was issued to the institution on 04.02.19. The institution has submitted its reply received in SRC office on 25.02.2019.

AND WHEREAS, the matter was considered by the SRC in its 375<sup>th</sup> meeting held from 13th &14th May 2019 and the Committee decided as under:-

Photocopy of Building Plan submitted not approved by the competent authority.
The institution has submitted photocopy of Building Plan not approved by
Competent Authority. The name of institution, course, total land area, total built
up area and earmarked area for each course being run in the same premises not
mentioned. As per previous photocopy of building plan submitted, it is mentioned
as proposed construction of residential school building

· Original FDRs are not submitted towards the Endowment and Reserve Fund of

Rs 12 Lakh in joint account of RD, SRC with 5 years validity.

• As per BCC, the land is in the name of Shri Sanjay Singh Kotarpur Shahabazar, Gulbarga. Approving Authority is in regional language

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Aryan B.Ed College, 34/A, Kotnoor 'D' Idga Maidan, Naganahalli Cross Ring Road, Gulbarga, Karnataka -02 run by Shankar Singh Memorial Trust, Sy. No.34/A, Kotnoor (D), Idga Maidan, Naganhalli Cross, Ring Road, Kalaburagi, Karnataka for B.Ed course from the end of the academic session as per provision of NCTE Act on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order.
