**CONTINUATION ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **Aryan B.Ed. College, No. 147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga-585105, Karnataka** vide SRC NCTE order No. F.SRO/NCTE/B.Ed/2004-2005/9869 dated 05.01.2005 for Secondary (B.Ed.) course of one-year duration from the academic session 2004-2005 with an annual intake of 100 students.

**2. AND WHEREAS**, the institution is permitted to shift to its permanent new premises at **Aryan College of Education, 34/A, Kotnoor 'D', Idga Maaidan, Naganahalli Cross Ring Road, Gulbarga, Karnataka** for conducting B.Ed. course vide order No. F.No.APS02315-B.Ed/KA/2011/33409 dated 08.12.2011.

**3. AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 27.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. courses of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**4. AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on dt. 04.02.2019. The institution has submitted its reply received in SRC office on 25.02.2019.

**5. AND WHEREAS**, the SRC in its 375<sup>th</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> May 2019 considered the matter and decided to withdraw the recognition for B.Ed. course. Accordingly, withdrawal order No. F.SRO/NCTE/APS02315/B.Ed/KA/2019/104637-4643 was issued to the institution on 23.05.2019.

**6. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.89-34/E-153328/2020 Appeal/10<sup>th</sup> Mtg.-2020/22<sup>nd</sup> July, 2022 dated 15.09.2020 and the Council remands back the case.

**7. AND WHEREAS**, the matter was considered by the SRC in its 394<sup>th</sup> meeting held on 27<sup>th</sup>-28<sup>th</sup> January 2021 and the Committee in the light of Hon'ble High Court direction in W.P.C. No. 337 of 2021 decided to seek legal opinion in the matter. Accordingly, the matter was referred to Legal Consultant, NCTE and it was opined that that matter be reconsidered as per direction of the Hon'ble Court.

**8. AND WHEREAS**, the matter was finally considered by the SRC in its 397<sup>th</sup> meeting held on 25<sup>th</sup> - 26<sup>th</sup> March, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the Hon'ble High Court set aside the impugned orders of the SRC dated 23.5.2019 and Appellate Authority order dated 15.9.2019 and directed SRC to reconsider the case of the petitioner in light of the original/certified copies of the documents.

The Committee on the perusal of the reply dated 18.1.2021 submitted by the institution and decided that the **continuation order** be issued to the Institution **Aryan College of Education, Survey No. 34/A, Kotnoor (D.), Idga Maidana, Naganahalli Cross, Ring Road, Kalaburagi-585102, Karnataka** for B.Ed. programme for **2 basic units of 100 students**.

9. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Aryan College of Education, Survey No. 34/A, Kotnoor (D.), Idga Maidana, Naganahalli Cross, Ring Road, Kalaburagi-585102, Karnataka** run by **Shankar Singh Memorial Trust, 34/A, Kotnoor (D.), Idga Maidana, Naganahalli Cross, Ring Road, Kalaburagi-585102, Karnataka** for continuation of recognition for B.Ed. course for two years duration (**2 basic units**) of 100 students subject to fulfilment of the following conditions:


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;



- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.


14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.


