### CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Navaa College of Education, Plot/Khasara No. 411/1B, Street No. 411, Chinnamuthur Village, Muthur Post & City, Kangeyam 638105. Tamilnadu vide SRC (NCTE) District Erode SRO/NCTE/SRCAPP3225/B.Ed/TN/2017-2018/92110 dated 02.03.2017 for conducting Secondary B.Ed. course of two-years duration with an annual intake of 100 students from the academic session 2017-2018.



- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered 2. the matter and also directed that the RD, SRC to issued SCN/FSCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 22.01.2021. The institution vide letter dated 02.02.2021 submitted reply to the Show Cause Notice
- AND WHEREAS, the matter was placed before the SRC in its 397th meeting held on 25th 26th March 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution and decided that the continuation order be issued to the Institution Navaa college of Education, Survey No.411/1B Chinna muthur village Kangayam Taluk, Tiruppur District-638105, Tamilnadu for B.Ed programme for 2 basic units of 100 students.



- NOW THEREFORE, this order is issued permitting the institution i.e. Navaa college of Education, Survey No.411/1B Chinna muthur village Kangayam Taluk, Tiruppur District-638105, Tamilnadu run by Vivekanada Educational Trust, Plot No. 411/1B, Erode Road, Town, Muthur Post & City, Kangeyam Taluk, Erode District - 638105, Tamilnadu for Continuation of recognition for B.Ed. programme for 2 basic units of 100 students subject to fulfilment of the following conditions:
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in the NCTE 11. Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in III. terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff duly approved by affiliating IV. body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be prescribed by 5. other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
