CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Amman College of Education Pillaiyarnatham, Dindigul — 624002, Tamil Nadu vide SRC (NCTE) order no. FSECONCTE/B Ed./2005-2006/5108 dated 04.01.2006 for conducting Secondary B.Ed. course distribution with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, the SRC vide order no. F.No.APS03630/B.Ed./TN/2011-12/30864

 14.10.2011 permitted the shifting of premises from Amman College of Education, VSKS

 15.10.2012 Pass Road, Pin-625001, Dindigul District, Tamil Nadu to Amman College of Education, Pillayamatham, Dindigul-624002, Tamil Nadu.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is a manual dated 27.01.2015 & for its willingness for adherence of provisions of new Peguations A revised provisional recognition order was issued to the institution on 21.04.2015 and B.Ed. courses of two years duration with an annual intake of 100 (Two basic academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institution of the revised recommendate was placed before the SRC in its 369th meeting held on 28.01.2019 and the Commendate decided that Show Cause Notice be issued to all such institutions which have not such institutions. Accordingly, Show Cause Notice was issued on 10.10.2019. The institution wide letter dated 14.11.2019 submitted its reply to the Show Cause Notice.
- AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th 3 19th September 2019, a common decision was passed against the institution which have not submitted any reply of Show Cause Notice, a Final Show Cause Notice be issued to all such institutions. Accordingly, a Final Show Cause Notice was issued on 21.01.2020 inadvertently, as the institution already submitted its representation on 14.11.2019. The institution vide letter dated 10.02 2020 submitted its reply along with the documents to the Final Show Cause Notice.
- 6. AND WHEREAS, the SRC in its 396th Meeting held on 03rd March 2021 the matter was placed before the Committee and decided to issue a Letter to the institution. As per decision of SRC, a letter was issued to the institution on dt. 15.03.2021. The institution has submitted reply of letter vide dt. 17.03.2021.
- 7. AND WHEREAS, the matter was placed before the SRC in its 397th meeting held on 25th 26th March 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution and decided that the continuation order be issued to the Institution Amman College of Education, Survey No. 134/1A1, Pillaiyarnatham, Panchayat Athoor Panchayat Union, Dindigul-624002, Tamilnadu for B.Ed. programme for 2 basic units of 100 students.

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Amman College of Education, Survey No. 134/1A1, Pillaiyarnatham, Panchayat Athoor Panchayat Union, Dindigul-624002, Tamilnadu run by Amman Educational Trust, 32/1A, Scheme Road, Y.M.R. Patty, Dindigul 624001, Tamil Nadu for Continuation of recognition for B.Ed. programme for 2 basic units of 100 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the

NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

- Name of Students admitted during the current session along with qualification.
 Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
