ORDER

In terms of Section 15(1) of the NCTE Act, 1993 **Sree Narayana College of Education, Mahe, Union Territory of Pondicherry-673310, Pondicherry** had submitted an application to the Southern Regional Committee of NCTE for grant of permission for starting **B.Ed(Additional Intake)** of **one year duration** from the academic session **2004-2005** with an annual intake of **20 (Twenty only)** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following.

- a) The institution has acquired the land for setting up the teacher education institution.
- b) The institution has selected **Ten** teachers for the said course and the staff list has been duly approved by the Pondicherry University, Pondicherry.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Sree Narayana College of Education, Mahe, Union Territory of Pondicherry-673310, Pondicherry** for **B.Ed (Additional Intake)** course of **one year duration** from the academic session **2004-2005** with an annual intake of **120** students including existing intake of **100** students and an additional intake of **20** students subject to fulfillment of the following.

- a) The institution will ensure that **Ten** faculty members are in position for an annual intake of **120** students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course.
- b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- c) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).

d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC/University/State/government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report (PAR) at the end of each academic year along with a copy of the approval of the affiliating University/State Directorate of Education of the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
