WHEREAS, the institution namely, Institute of Education, Thogamali Road, Pothavur Village, Inampuyur Post, Sriranga Taluk, Trichy District – 639103, Tamilnadu was granted recognition for offering B.Ed course vide SRC NCTE's order dated 25.07.2006 of one year duration with an intake of 100 students.

AND WHEREAS, the matter of shifting of premises to own / permanent building was placed before the SRC in its 213th meeting held on 6-7 November 2011. The Committee considered the VT report and decided to permit for shifting of premises to own new building at "Institute of Education, Thogamali Road, Pothavur Village, Inampuyur Post, Sriranga Taluk, Trichy District, Pin -639103, Tamil

AND WHEREAS, on 24.1.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 31.03.2015 for offering B.Ed course of two years duration with an intake of 100 students (2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the institution namely, Institute of Education, Thogamali Road, Pothavur Village, Inampuyur Post, Sriranga Taluk, Trichy District - 639103, Tamilnadu was granted recognition for offering B.Ed-AI course vide SRC NCTE's order dated 28.05.2008 of two year duration with an intake of 100 students.

AND WHEREAS, on 24.1.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 21.04.2015 for offering B.Ed-AI course of two years duration with an intake of 200 students (4 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance.

AND WHEREAS, as per the decision of SRC a Show Cause Notice was issued to the institution on 07.05.2019. The institution has not submitted any reply in respect of Show Cause Notice.

AND WHEREAS, the SRC in its 380th meeting, a common decision was passed against the institution which have not submitted any reply of SCN a Final Show Cause Notice be issued to all such institutions. Accordingly, a Final Show Cause Notice was issued on 18,11,2019.

AND WHEREAS, the institution vide letter dt 05.12.2019 filed a Writ Petition No. 23313/2017 from Hon'ble High Court of Madras.

"It is pertaining to mention that the institution had submitted a copy of Hon'ble Court Order but the same pertains to QCI and is not related with the instant First and Final / Second Show Cause Notice and hence these Show Cause Notices does not contradict the Hon'ble Court order"

Further, the institution had not submitted any reply / document in response to First and Final Show Cause Notices and only mentioned in the letter for not taking any action on the basis of Court Order.

AND WHEREAS, the matter was placed before the Committee in its 384th meeting held on 12th – 13th February 2020. The Committee considered the matter and decided to withdraw the recognition granted to the institution for B.Ed course. Accordingly, a Withdrawal order was issued on 21.02.2020.

AND WHEREAS, the institution has filed a Writ Petition vide WP No. 5908 of 2020 in Hon'ble High Court of Madras.

AND WHEREAS, the matter was placed before the SRC in its 386th meeting held on 23rd – 24th July, 2020 considered and decided to issued a **Final Show Cause Notice** to the institution.

AND WHEREAS, a Final Show Cause Notice was issued to the institution vide dated 04.08.2020. The institution has submitted along with documents vide dated 24.08.2020.

AND WHEREAS, the matter was finally considered by the SRC in its 388^{th} Virtual Meeting held from 14^{th} – 15^{th} September 2020 decided as under: -

"On the perusal of the reply submitted by the institution vide letter dt. 24.08.2020, the Committee decided that the continuation order be issued to the Institution Institute of Education, Trichy District – 639103, Tamilnadu for B.Ed programme for 4 basic unit of 50 students each unit."

NOW THEREFORE, this order is issued permitting the institution Institute of Education, S. No. 176/3, 178/1, 178/5, 178/4F, 176/6E, 176/2, 178/2A, 178/2B, 176/4B, 178/6B, 176/5, Thogamali Road, Pothavur Village, Inampuyur Post, Sriranga Taluk, Trichy District, Pin -639103, Tamil Nadurun by Rahul Gandhi Educational & Charitable Trust, 10G, New Colony, Salai Road, Woraiyur, Trichirapalii – 620003, Tamil Nadu for continuation of conducting B.Ed course of two years duration with an annual intake of 4 basic units (50 students each unit) subject to fulfillment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if e. Fee charged from students;
- f. Available infrastructural facilities;
- Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website.
- The institution shall fill the information on GIS Portal on the NCTE Website. 11.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
