ORDER

WHEREAS, the institution Bhagwan Budha College of Education, 551/A2, #0421, 5th Cross, Siddartha Nagar, Malvalli, Mandya District – 671430, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/235 dated 20.01.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 01.04.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, in the meantime, in 314th meeting held on 27th & 28th May, 2016 the SRC taken general decision to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016 and the inspection was conducted vide dated 21.10.2016 and the VT report along with documents received on 24.10.2016.

AND WHEREAS, the matter was placed before the SRC in its 348th meeting held on 05th – 06th December, 2017 considered and decided to issue a Show Cause Notice. As per decision, a SCN was issued to the institution vide dated 12.12.2017.

AND WHEREAS, the institution was submitted a letter vide dated 28.10.2016, as stated it has not deposited 1,50,000/- for inspection fee and has also not submitted any documents pertaining to land and building as requested a letter vide dated 25.02.2015.

AND WHEREAS, the matter was placed before the SRC in its 329th meeting held on 06th & 07th February, 2017 considered the matter decided as under:

- 1. They are avoiding compliance.
- 1.1 They have not submitted documents.
- 1.2 They have not paid the fee.
- 1.3 They have not co-operated for the VT inspection.
- 2. Issue SCN for action as indicated and also suggest a convenient date for VT inspection.
- 3. Issue a time-limit for response by 20.03.2017.

AND WHEREAS, a Show Cause Notice was issued to the institution vide dated 17.02.2017 and the institution has not submitted any reply of the same.

AND WHEREAS, a writ petition was filed by the institution in respect of WP no.27.02.2020 in the Hon'ble High Court of Karnataka at Bengaluru.

AND WHEREAS, the above matter was placed before the SRC in its 388th meeting held on 14th – 15th September, 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to the institution to submit the written representation against the conditions mentioned therein.

AND WHEREAS, a Final Show Cause Notice was issued on 07.09.2020. The institution has submitted its reply on 29.09.2020.

AND WHEREAS, the matter was placed before the SRC in its 389th meeting held on 12th & 14th October, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

(i) On the perusal of the reply submitted by the institution vide letter dt. 29.09.2020, the Committee decided that the continuation order be issued to the Institution Bhagwan Budha College of Education, Malvally-671430, Mandya District, Karnataka for B.Ed programme for 2 basic unit of 50 students each."

NOW THEREFORE, this order is issued permitting the institution i.e. Bhagwan Budha College of Education, 551/A2, #0421, 5th Cross, Siddartha Nagar, Malvalli, Mandya District – 671430, Karnataka for continuation of recognition for B.Ed. programme for 2 basic unit of 50 students each subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 5. The institution shall make available the list of students admitted on its official website.
- 6. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
