**Withdrawal Order**

WHEREAS, Mankada Orphanage Teacher Training Institute, Mankada Anadhasala Sangham, Malappuram District, Pin - 679324, Kerala had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for increase of intake of 50 to Elementary course of two years duration from the academic session 2005-2006 with an annual intake of 100 students which includes the existing intake of 50 and an additional intake of 50 and was granted recognition on 28.09.2005 with the condition that the institution shall shift to its own premises within three years from the date of recognition (In case the course is started in temporary premises).

AND WHEREAS, in the mean time, a letter dated 27.8.2014 of the secretary of Mankada Anadhasala Sangham, Malappuram District, Pin-679324, Kerala, is received by this office on 02.09.2014 stating as under:-

"Mankada Anadhasala Sangham, Mankada started self financing Teacher Training Institution at Mankada, Malappuram District from the academic year 2004-2005, with an annual intake of 50 students strength. w.e.f 11.10.2004 as per sanction of NCTE and Education Department Govt of Kerala. Due to high rush of candidates, we forced to apply for starting an additional intake of 50 students for Teacher Training Course and application for the same were submitted on 27.12.2004 and sanction were given for additional intake of 50 students and admission was started from 2005-2006 academic year onwards.

The institution was functioning smoothly with 100 Teacher Trainees intake every year with an excellent academic result and social activities at the locality however from the last year onwards number of applicant for trainees were considerably reduced and faced difficulty to admit for even one unit and could not to fill one unit of 50 students.

In this circumstances we avoided admission to the additional intake batch and we think off to stop the additional intake of 50 students and may please be sanctioned. There for the FD remitted on joint operation for additional unit may kindly be released so as to utilize the amount for other useful welfare purpose of Mankada Andhasala Sangham, Mankada."

AND WHEREAS, the Southern Regional Committee in its 273<sup>rd</sup> Meeting held during 30<sup>th</sup> September & 1<sup>st</sup> October, 2014 considered the Institutions request for closure of T.T.C.-AI course and decided to permit the closure by withdrawing the recognition for (APSO1055) T.T.C.-AI course with effect from 2014-2015, in order to enable the ongoing batch of students in T.T.C.-AI course, if any, to complete their final year course.

**AND WHEREAS**, but is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order. The Affiliating body / Examining board / body be informed accordingly. further decided to return Endowment funds and Reserve fund deposited with SRC NCTE, Bangalore. If any, after ensuring settlement of all faculty/staff claims.

**NOW THEREFORE**, as per the decision of 273<sup>rd</sup> Meeting of SRC held during 30<sup>th</sup> September, & 1<sup>st</sup> October, 2014 recognition of **Mankada Orphanage Teacher Training Institute, Mankada Anadhasala Sangham, Malappuram District, Pin - 679324, Kerala for T.T.C-AI course (APSO1055)** is hereby withdrawn as per the request of the institution, from the academic session 2014-2015.
