WITHDRAWAL ORDER

WHEREAS, recognition was granted to Jnana Bharathi College of Education, N.H. 206, Kadur Chikmagalur - 577548, Karnataka run by Jnanabharathi Home for Education, Karnataka vide order dated 01.12.2004 for running B.Ed. course of one year duration with an annual intake of 100.

AND WHEREAS, a Show Cause Notice No. APSO2162/B.Ed./KA/2011-12/29133 dated 15.6.2011 was issued to the institution (shifting case). The institution has not submitted any reply as per the records available in file.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure), Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

AND WHEREAS, the institution by a notarized affidavit dated 05.02.2015 consented to come under the new Regulations. In light of the above and in accordance with the NCTE Regulations, 2014, the SRC, NCTE issued the revised recognition order dated 31.05.2015 to Jnana Bharathi College of Education, N.H. 206, Kadur Chikmagalur - 577548, Karnataka for conducting B.Ed. course of two years duration with an annual of 100 students (two basic units) of 50 students each from the academic session 2015-16 subject to fulfillment of the conditions mentioned therein.

AND WHEREAS, a corrigendum No. F. SRO/NCTE/APSO2162/B.Ed./KA/2015-16/69053 dated 01.07.2015 was issued to the institution for conducting B.Ed. programme of two years duration with an annual of 50 students (one basic unit) from the academic session 2015-16 subject to fulfillment of the conditions mentioned therein.

AND WHEREAS, the matter regarding complaint by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, a Show Cause Notice was issued to the institution on 12.2.2019.

AND WHEREAS, the institution vide letter dated 05.3.2019 received on 12.3.2019 has informed as under:

With reference to your letter we have already deposited endowment fund of Rs. 419799.00 on 7.12.2015 and its maturity dated is 23.11.2020 and its amount is 601262.00. it is also renewed on 07.12.2015. we have also deposited reserve fund amount of Rs. 699666.00 on 7.12.2015 and its maturity dated is 23.11.2020 and its amount is 1002104.00. It is also renewed on 7.12.2015. so we kindly request you to inform us that mentioned deposits are ok to you or else if we have to take fresh deposit receipts for today date. Pls send us the specific application forms. We also request you to kindly suggest regarding this.

AND WHEREAS, as per the records available in file, the original FDRs of Rs. 5 & 3 lakhs were returned to the institution vide letter dated 21.7.2015.

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th -12th June, 2019 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to **withdraw the recognition** granted to Jnanabharathi College of Education, N.H. 206, Kadur Chikmagalur – 577548, Karnataka for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the following grounds: -

1. The institution in-spite of two SCNs is reluctant to furnish the required information for the continuation of recognition in view of non-availability of the documents, the Committee decided to withdraw the recognition.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Jnana Bharathi College of Education, N.H. 206, Kadur Chikmagalur – 577548, Karnataka run by Jnanabharathi Home for Education, K.M. Road, Kadur-577548, Karnataka for B.Ed course from the end of the academic session as per provision of NCTE Act on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website http://ncte.gov.inwithin 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
