ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **S.N.S. Samajam Sree Bhadrachala Subrahmanya Temple, P.O.Edamuttam, Thrissur, Kerala** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting T.T.C course with an annual intake of 50 on 27/12/2004.

Samajam Teacher Training Institute, X/27, Sreenarayana Hall, Near Shri Bhadrachala Subramania Temple, Near Edamuttam, N.H 17, Edamattum Post, Thrissur 680568, Kerala** for conducting T.T.C Course of 2 year duration with an annual intake of 50 from the academic session 2009-2010 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:

I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
