WITHDRAWAL ORDER

Recognition was granted to the institution namely **Suprabhath College of Diploma in Education, Khasara No. Sy.No. 147/A, Cheeryal Village, Keesara Post & Taluk, Hyderabad City, Rangareddi District – 501101, Andhra Pradesh** run by **KTTC Kaushik Educational Society, Plot No. Sy No. 147/A Cheeryal Village, Keesara Post & Taluk, Hyderabad City, Rangareddi District- 201301, Andhra Pradesh** vide SRC (NCTE) order no. F.No.SRCAPP1346/D.El.Ed/AP/2013-14/52888 dt. 29.07.2013 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2014-2015.

AND WHEREAS, the institution vide letter dated 18.06.2019 received on 21.08.2019 requested for closure of D.El.Ed. programme. The SRC in its 379th meeting held on 21st – 22nd August, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to **withdraw the recognition granted to Suprabhath College of Diploma in Education, Khasara No. Sy. No. 147/A, Cheeryal Village, Keesara Post & Taluk, Hyderabad City, Rangareddi District – 501101, Andhra Pradesh** for conducting D.El.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Suprabhath College of Diploma in Education, Khasara No. Sy. No. 147/A, Cheeryal Village, Keesara Post & Taluk, Hyderabad City, Rangareddi District – 501101, Andhra Pradesh** run by **KTTC**

Kaushik Educational Society, Plot No. Sy. No. 147/A, Cheeryal Village, Keesara Post & Taluk, Hyderabad City, Rangareddi District-501301, Andhra Pradesh for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
