ORDER

WHEREAS, Devanahally Education Trust, Devanahally, Bangalore, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Nalanda College of Education, P.B.No.10, D.S.Road, Devanahally-562110, Bangalore Rural District, Karnataka for Secondary (B.Ed) course of one year duration from the academic session 2004-05 with an annual intake of 100 students and was granted recognition on 25.11.2004 with a condition to shift to its own premises / building within three years from the date of recognition (in case the course is started in rented premises).

- 2. AND WHEREAS, on 23.01.2015, the institution has submitted an affidavit for offering B.Ed course with an intake of 2 units. The revised order was issued to the institution on 16.05.2015 with an intake of 100 students (two units of 50 each).
- 3. AND WHEREAS, after long deliberation the SRC in its 378th meeting held during 25th -26th July, 2019 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) The committee noted that the institution has submitted documents of the land & building at a new address. Therefore, the SRC decided to conduct VT for ascertaining the infrastructure & instructional facilities at a new location/premises.
- (ii) The committee also noted that there was a complaint against the institution and the SRC in its 349th meeting decided "Ask the complainant to confirm their complaint through an affidavit." A letter to this effect be sent to complainant.
- **4. AND WHEREAS,** as per the direction of SRC, the inspection of the institution was conducted on 3rd Sept 2019 and the VT Report received in the office of SRC on 11th Sept 2019.
- **5. AND WHEREAS,** the matter was finally considered by the SRC in its 380th meeting held from 18th 19th September, 2019 decided as under:-

"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Nalanda College of Education, Bangalore Rural District, Karnataka for B.Ed programme for 1 unit (50 students)."

Sulibele, D.S. Road, Bangalore-562110, Karnataka run by Devanahally Education Trust, Devanahaly, Bangalore – 562110, Karnataka for continuation of conducting B.Ed course of two years duration with an intake of 50 students (1 basic unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities:
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
 - i. The affidavit with enclosure submitted along with application.
 - i. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available the list of students admitted on its official website.
- 11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
