ORDER

WHEREAS, the institution namely Bharath College of Education, K. Nadimuthu Memorial Education, Near New Bus Stand, Trichy Road, Thanjavur District-613005, Tamilnadu was granted recognition for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2008-2009 vide SRC, NCTE's vide order no. F.SRO/NCTE/B.Ed./2008-2009/3573 dt.05.08.2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.18.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, provisional revised recognition order (RPRO) was issued to the institution on 23.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted compliance with relevant documents vide letters dt. 28.10.2015 & dt.26.02.2016.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 14.06.2016 and the inspection was conducted on 09.09.2016.

AND WHEREAS, the matter was placed before the SRC in its 340th meeting held on 08th - 09th June 2017 wherein the Committee considered the matter and decided as under:

- 1. Certified copy of Sale deed not given. The photocopy shows title to Sy.No.236/1B (1 acre). Land area is adequate.
- 2. LUC and EC are in order.
- 3. BP is in A4 sheet, a photocopy. Not approved by competent authority. Blue print not given. BP is not legible.
- 4. BCC shows built-up area of 2219 sq.mts. But, it is not approved by competent authority.
- 5. FDRs need to be revalidated in joint account.
- 6. Faculty list is not in format. Not approved.
- 7. Issue SCN accordingly.

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 15.06.2017. The matter was placed before the SRC in its 375th meeting held on 13th - 14th May 2019 wherein the Committee considered the matter and decided as under:

"The Committee decided to withdraw the recognition granted to Bharath College of Education, K. Nadimuthu Memorial Education, Near New Bus Stand, Trichy Road, Thanjavur District -613005, Tamilnadu for conducting B.Ed. course as the institution has not submitted any reply to the Shos Cause Notice dt. 15.06.2017."

Thereafter, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No. 89-211/E-119600/2019 Appeal/20th Mtg.-2019/8th July, 2019 dt.30.07.2019 remanded back the matters of Additional Intake in B.Ed. courses respectively to SRC. The operative part of the orders is as under: -

Operative part of Order No. 89-211/E-119600/2019 Appeal/20th Mtg.-2019/8th July, 2019 dt.30.07.2019 in respect of additional intake in B.Ed. course: -

"AND WHEREAS, the Committee, noted that the appellant's reply dt.04.07.2017 is not in the file of the SRC. Since the appellant has shown evidence of their sending the reply, the Committee concluded that the matter deserved to be remanded to the SRC with a direction to consider that the of the appellant dt. 04.07.2017, to be sent to them again by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the SRC their reply dt. 04.07.2017, with all its enclosures, within 15 days of receipt of orders on the appeal.

AND WHEREAS, after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded to remand back the case to the SRC with a direction to consider the reply of the appellant dt. 04.07.2017, to be sent to them again by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the SRC their reply dt.04.07.2017, with all its enclosures, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Bharath College of Education, Neelagiri, Therkku Thottam, Bharath Avenue Thanjavur, Tamilnadu to the SRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the institute had submitted its reply on 13.08.2019 along with the documents The SRC in its 380th meeting held on 18th -19th September 2019 considered the reply submitted by the institution and decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Bharath College of Education, K. Nadimuthu Memorial Education, Near New Bus Stand, Trichy Road, Thanjavur District-613005, Tamil Nadu for B.Ed programme for 2 units (50 students each unit).

NOW THEREFORE, this order is issued permitting the institution Bharath College of Education, K. Nadimuthu Memorial Education, Near New Bus Stand, Trichy Road, Thanjavur District-613005, Tamilnadu run by K. Nadimuthu Memorial Education Trust, No.29/88, 4th Cross, Parisutham Nagar, Thanjavur-613007, Tamilnadu for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units of 50 students each) subject to fulfilment of the following conditions:

to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
