ORDER

WHEREAS, the recognition was granted to the institution, namely **Noor M.Ed College, Noor Colony Horticuture Centre, Haladkeri, Hyderabad Road, Bidar District – 585401, Karnataka run by Noor Educational Trust** for conducting M.Ed. course of one year duration with an intake of 25 students vide order No. **F.SRO/NCTE/M.Ed./2006-2007/15255** dated **22.11.2007**.

2. **AND WHEREAS**, the enhancement of intake of 10 seats from existing 25 to 35 was permitted to **Noor M.Ed College, Noor Colony Horticuture Centre, Haladkeri, Hyderabad Road, Bidar District – 585401, Karnataka** for M.Ed course w.e.f. the session 2010-2011 on **24.08.2010**.

3. **AND WHEREAS**, on promulgation of NCTE Regulations 2014, the institution by a notarized affidavit dated **17.06.2015** consented to come under new Regulations and sought for one basic unit of 50 students of two years M.Ed. course which required additional facilities.

4. **AND WHEREAS**, revised provision recognition order dt. **01.07.2015** was issued to **Noor M.Ed College, Noor Colony Horticuture Centre, Haladkeri, Hyderabad Road, Bidar District – 585401, Karnataka** for conducting M.Ed. course of two years duration with an annual intake of one basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned in the revised order.

5. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on **28.01.2019** and the Committee decided that Show Notice be issued to all such institutions which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on **12.02.2019**.

6. **AND WHEREAS**, the institution submitted its reply vide letter dated **14.03.2019**. The institution has submitted letter granting approval for appointment of faculty by the Registrar, Gulbarga University. The institution has not submitted the list of faculty as approved by the affiliating university in the prescribed format.

7. **AND WHEREAS**, the SRC in its 377th meeting-held on 03rd & 04th July, 2019 considered the matter and decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice

8. **AND WHEREAS**, as per the decision of SRC a Final Show Cause Notice was issued to the institution on **16.07.2019**. The institution vide letter date **12.09.2019** and **16.09.2019** submitted its reply to the Final Show Cause Notice.

9. **AND WHEREAS**, the matter was finally considered by the SRC in its 380th meeting held from 18th – 19th September, 2019 decided as under:-

“On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Noor M.Ed College, Noor Colony Horticulture Centre, Haladkeri, Hyderabad Road, Bidar District – 585401, Karnataka for M.Ed programme for 1 unit (50 students).”

10. **NOW THEREFORE**, this order is issued permitting the institution **Noor College of Education, Sy. No. 61/A C.M.C. 14-5-329, Noor Colony, Near Horticulture Center, Hyderabad Road, Bidar – 585401, Karnataka**, run by **Noor Education Trust, Hyderabad Road Bidar – 585401, Karnataka** for continuation of conducting **M.Ed** course of two years duration with an intake of 50 students (1 basic unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
