**ORDER**

WHEREAS, recognition was granted to the institution namely Amrutha College of Education, S.No. 46-1B ,Alape Village ,Mangalore, Karnataka run by Sunada Education Trust, Mangalore District, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/APSO8959/B.Ed/2006-2007/14228 dt. 06.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, on 09.02.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 16.05.2015 for offering B.Ed course of two years duration with an intake of 100 students ( 2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

3. AND WHEREAS, the institution submitted a letter on 28.06.2016 requesting for reduction intakes from 2 units to 1 unit.

4. AND WHEREAS, on 30.10.2015, the institution submitted a reply to the revised order issued along with relevant documents. The SRC in its 314<sup>th</sup> meeting held during 27<sup>th</sup> to 28<sup>th</sup> May, 2016 considered the matter. As per the decision of SRC, an inspection letter was issued to the institution on 13.06.2016 about the scheduled inspection of the institution for 2 units of the course.

5. AND WHEREAS, on 28.06.2016, the institution submitted a written representation requesting therein to sanction 1 unit only (50 students).

6. AND WHEREAS, the above matter was placed before the SRC committee in its 321<sup>st</sup> meeting held on 28<sup>th</sup>& 30<sup>th</sup>September, 2016. The committee considered the matter and decided as under: -

*"We should use this opportunity to verify the basic facts with respect to documents in all such RPRO cases many of which relate to very old FRs issued by us, R.D may collect – Land deeds, LUC, EC, BP, BCC, FDRs and Faculty Lists and get them processed by office so that we can critically scrutinize the facts and take appropriate decisions about issue of new FRs."*

7. AND WHEREAS, a letter dt 15.10.2016 was issued conveying the above decision to the institution. Subsequently a Show Cause Notice was also issued to the institution on 26.02.2019.

8. **AND WHEREAS**, the institution submitted its reply against the Show Cause Notice issued on 26.02.2019 and the SRC in its 375<sup>th</sup> meeting 30<sup>th</sup> April & 1<sup>st</sup> May, 2019 considered the matter and decided as under:-

*The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee decided to withdraw the recognition granted to Amrutha College of Education, S.No. 46-1B, Alape Village, Mangalore, Karnataka for conducting B.Ed. course on the following grounds: -*

- a) *Certified land documents issued by the competent authority not submitted.*
- b) *LUC issued by the competent authority.*
- c) *The latest Non-Encumbrance Certificate issued by the competent authority not submitted.*
- d) *Original BCC issued by the competent authority not submitted.*
- e) *Faculty list in original approved by the affiliating body not submitted.*
- f) *FDRs are in original not submitted towards the Endowment and Reserve Fund of Rs 12 Lakh in the joint account RD, SRC with 5 years validity.*

9. **AND WHEREAS**, as per the decision of SRC, a withdrawal order no. F.SRO/NCTE/APSO8959/B.Ed/KA/2019/104644-4650 dated 23.05.2019 was issued to the institution.

10. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.91-22<sup>nd</sup>/23<sup>rd</sup>/24<sup>th</sup> Mtg./2019-/Appeal/81734 dated 03.09.2019 and the Council remands back the case. The operative part of the Appeal order is as under:-

**"The Committee noted that the letters of the appellant dt. 24/05/2019 and 29/05/2019 written after the issue of withdrawal order dt. 23/05/2019 are in the file of the SRC. The appellant enclosed copies of the documents sent to SRC to the appeal. In these circumstances, the Committee concluded that the matter deserved to be remanded to the SRC with a direction to consider the documents submitted by the appellant with their letters dt. 24/05/2019 and 29/05/2019 and take further action as per the NCTE Regulation 2014. While doing so SRC should consider the shortage in the built-up area, which as per the BCC submitted to them by the appellant with their letter dt. 24/05/2019, shows only a built up area of 11,560 sq.ft. (including basement).**

**After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the SRC with a direction to consider the documents submitted by the appellant with their letter dt. 24/05/2019 and 29/05/2019 and take further action as per the NCTE Regulations, 2014. While doing so SRC should consider the shortage in the built-up area, which as per the BCC submitted to them by the appellant with their letter dt. 24/05/2019, shows only a built-up area of 11,560 sq.ft. (including basement)."**

**The Council hereby remands back the case of Amrutha College of Education, Alapa, Padil, Mangalore, Karnataka to the SRC, NCTE for necessary action as indicated above."**

**11. AND WHEREAS,** the matter was finally considered by the SRC in its 380<sup>th</sup> meeting held from 18<sup>th</sup> – 19<sup>th</sup> September, 2019 decided as under:-

*"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Amrutha College of Education, S.No. 46-1B, AlapeVillage, Mangalore, Karnataka for B.Ed programme for 1 units (50 students)."*

**12. NOW THEREFORE,** this order is issued permitting the institution Amrutha College of Education, S.No.46-1B, Alape Village, Mangalore – 575007, Karnataka run by Sunaada Educational Trust, Padil, Mangalore – 575007, Karnataka for continuation of conducting B.Ed course of two years duration with an intake of 50 students (one basic unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

**13.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

**14.** The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

**15.** The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

17. The institution shall make available the list of students admitted on its official website.

18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
