WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 (1) of NCTE Act, 1993 was granted to the institution namely, Annai Madha Teacher Training Institute, Trichy Main Road, Edaicheruvai, Akkanur Post, Tittagudi Taluk, Cuddalore District, TamilNadu run by Christhuva Madha Kalvikalacharam Samuga Niruvanam Trust, Cuddalore District, TamilNadu for D.T.Ed. & D.T.Ed.-AI programme as per following details:-

- (i) Vide Order No.F.TN/2067/SRO/NCTE/2004-05/8228 dated 02.11.2004 to offer Elementary course of two-years duration from the academic session 2004-05 with an annual intake of 50 students.
- (ii) Vide Order No.F.SRO/NCTE/2006-2007/8545 dated 11.10.2006 for D.T.Ed. (Additional Intake) course of two-years duration from the academic session 2006-2007 with an annual intake of 50 students.
- (iii) Vide Order No.F.SRO/NCTE/D.T.Ed-AI/2006-2007/18460 dated 28.02.2008 for conducting D.T.Ed. additional intake course of two-years duration with an annual intake of 50 students.
2. **AND WHEREAS**, a letter dated has been received from the institution on 02.09.2022 regarding closure of institution.
3. **AND WHEREAS**, the SRC in its 414th Meeting held on 26th – 27th September 2022 considered the matter request for closure and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 24.08.2022 by withdrawing the recognition granted to Annai Madha Teacher Training Institute, Trichy Main Road, Edaicheruvai, Akkanur Post, Tittagudi Taluk, Cuddalore District, TamilNadu for conducting D.T.Ed. & D.T.Ed.-AI Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting”.

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **Annai Madha Teacher Training Institute, Trichy Main Road, Edaicheruvai, Akkanur Post, Tittagudi Taluk, Cuddalore District, TamilNadu** run by **Christhuva Madha Kalvikalacharam Samuga Niruvanam Trust, Cuddalore District, TamilNadu** for conducting **D.T.Ed. & alongwith additional Programme** of two years duration with an annual intake of **50 + 50 + 50** with effect from the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.


