WHEREAS, the recognition was granted to the institution namely, Indhira College of Education, Pandur, Thiruvallur Taluk & District, Tamilnadu run by Indira Educational & Charitable Trust, Thiruvallur District, Tamilnadu vide SRC vide order no. F.SRO/NCTE/M.Ed./2007-2008/1512 dt. 06.05.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Indhira College of Education, Pandur, Thiruvallur Taluk & District, Tamilnadu vide order No. F.SRO/NCTE/2010-2011/20584 dt. 23.08.2010 from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 has considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 21.02.2019. The institution has submitted reply on 01.03.2019 & 13.03.2019.
- **5. AND WHEREAS,** the SRC in its 405<sup>th</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> December 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/ APS07731/B.Ed./TN/2021/129839 dated 07.01.2022 was issued to the institution.
- 7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-176/E-258506/2022 Appeal/8<sup>th</sup> Mtg.-2022 dated 16.11.2022 appeal remand back the order appealed against. The institution vide letter dated 05.12.2022 submitted reply to the appeal remand back order.
- **5. AND WHEREAS**, the SRC in its 418<sup>th</sup> Meeting held on 16<sup>th</sup> December, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Indhira College of Education, Survey No. 474/1, 2A, 2C, 2E, 2D, 475, 480/3A, 3B, 481/1A, 1B, 2A2, 2A3, 484/1A1, 2A1,

489/3B, VGR Gardens, VGR Nagar, Pandur, Thiruvallur Taluk, District-631203, Tamilnadu for M.Ed. programme for 1 basic unit of 50 students subject to the condition on submission of an Affidavit on Rs.100/- Non Judicial Stamp paper clearly mentioning the name and account number of each of the faculty appointed for M.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT. The Affidavit should be supported with documents like photocopy of passbook of each of faculty showing the disbursement of salary through bank account to individual faculty members (at-least for 3 months). After receipt of the same the RD, SRC is advised to issue continuation order only after obtaining the above required documents

- **6. AND WHEREAS,** as per decision of SRC a letter was issued to the institution on 22.12.2022. The institution has submitted bank statement vide letter dated 20.02.2023 according, to statement the salary is being disbursed through bank.
- 7. NOW THEREFORE, this order is issued permitting the institution i.e., Indhira College of Education, Survey No. 474/1, 2A, 2C, 2E, 2D, 475, 480/3A, 3B, 481/1A, 1B, 2A2, 2A3, 484/1A1, 2A1, 489/3B, VGR Gardens, VGR Nagar, Pandur, Thiruvallur Taluk, District-631203, Tamilnadu for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **8.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
