CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, Infant Jesus College of Education, Infant Jesus Edun and Chrt Tru, K Kallikudi, Ramjee Nagar Post, Trichy/Tiruchirapalli, Tamilandu-620009 run by Infant Jesus Educational and Charitable Trust, S.F. No.25/3, K.Kallikudi Village, Ramjee Nagar Srirangam, Trichy, Tiruchirapalli-620009, Tamilnadu vide SRC (NCTE) order no. F.SRC/NCTE/2009/B.Ed/RO/11982 dt. 24.04.2009 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2009-2010.

2. **AND WHEREAS**, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution dt. 27.02.2015 and the provisional revised recognition order was issued on 23.03.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issue to all such institutions which have not submitted compliance. Accordingly; a Show Cause Notice issued on 16.09.2019. The institution has submitted reply on 21.10.2019.

4. **AND WHEREAS**, the SRC in its 401st Meeting held on 11th & 12th August, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 31.08.2021. The institution did not submit reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided to withdraw the recognition. Accordingly as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS09784/B.Ed/TN/2021/129354 dated 01.12.2021 was issued to the institution.

6. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 14127/2022 & CM APPL 43161-43162/2022 titled as Infant Jesus College of Education Versus National Council for Teacher Education & Anr. In compliance of order dated 06.10.2022, the Regional Director, SRC has already passed an order dated 19.10.2022 vide order no. File No. SRO/NCTE/APS09784/B.Ed./TN/2022/136422-136424.

7. **AND WHEREAS**, the SRC in its 415th Meeting held on 03rd – 04th November 2022 was considered the matter and decided to write a letter to Registrar. Accordingly, as per the decision of SRC, a letter was issued to the Registrar, TNTEU on 22.11.2022.

8. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-209/E-

264415/2022 Appeal/11th Meeting, 2022 Appeal No.APPLSRC202114239 dated 11.01.2023 appeal remand back the order appealed against. The institution did not submit reply to the appeal remand back case.

9. **AND WHEREAS**, the SRC in its 421st Meeting held on 10th February 2023 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution has submitted reply received on 27.02.2023.

10. **AND WHEREAS**, the SRC in its 422nd meeting held on 02nd – 03rd March, 2023 has considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Infant Jesus College of Education, Survey No. 25/3AP1, 25/3AP2, 25/3AO1, 25/3AL, 25/AC9, 25/3AC7, K Kallikudi Panchayat, Srirangam Taluk, Tiruchirapalli District, Tamilandu-620009** for B.Ed. programme for 2 basic units of 50 students each.


11. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Infant Jesus College of Education, Survey No. 25/3AP1, 25/3AP2, 25/3AO1, 25/3AL, 25/AC9, 25/3AC7, K Kallikudi Panchayat, Srirangam Taluk, Tiruchirapalli District, Tamilandu-620009** for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office,




classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
16. The institution shall make available the list of students admitted on its official website.
17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
