AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 01.09.2022. The institution has submitted on 19.09.2022.
- **4. AND WHEREAS**, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution has submitted reply on 23.02.2023.
- 5. AND WHEREAS, the SRC in its 422nd meeting held on 02nd 03rd March, 2023 has considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Shaik College of Education, Survey No CSI 106424, People's Educational & Trust, Shaik Campus, Nehru Nagar, Belgaum, Karnataka-590010 for B.Ed. programme for 2 basic units of 50 students each.

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
