### **WITHDRAWAL ORDER**

WHEREAS, recognition u/s15(3)(a) of NCTE Act, 1993 was granted to the institution namely, Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana vide Order dated 18.10.2002 for conducting M.Ed. Course of one year duration.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 19.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 29.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students for one unit from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued on 25.11.2019. The institutions did not submit a reply to the First Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its  $402^{nd}$  meeting held on  $13^{th} 14^{th}$  September 2021 considered the matter and decided to issue a Last Reminder letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 07.10.2021. The institution did not submit a reply to the Last Reminder Letter.
- **5. AND WHEREAS**, the SRC in its 409<sup>th</sup> meeting held on 29<sup>th</sup> 30<sup>th</sup> March 2022 considered the matter and decided to Withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS02895/M.Ed./TS/2022/131432-131435 dated 13.04.2022 was issued to the institution.
- 6. AND WHEREAS, aggrieved by the Withdrawal Order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide Order No.89-137/E-255383/2022 Appeal/7<sup>th</sup> Meeting, 2022 Appeal No.APPLSRC202214366 dated 19.10.2022 appeal remand back the order appealed against. The institution vide dated 20.10.2022 submitted a reply to the Appeal Remand Back.
- 7. AND WHEREAS, the SRC in its 415<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> November 2022 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per

the decision of SRC, a Final Show Cause Notice was issued to the institution on 23.11.2022. The institution vide dated 07.01.2023 has submitted a reply to the Final Show Cause Notice.

- 8. AND WHEREAS, the SRC in its 419<sup>th</sup> meeting held on 13<sup>th</sup> January 2023 considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 27.01.2023. The institution vide dated 06.02.2023 has submitted a reply to the Last Reminder Letter.
- 9. AND WHEREAS, the SRC in its 422<sup>nd</sup> Meeting of SRC held on 02<sup>nd</sup> 03<sup>rd</sup> March 2023 considered the reply to Last Reminder Letter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Last Reminder Letter. The institution has submitted its reply vide letter dated 06.02.2023. The Committee perused the reply submitted by the institution and found the following deficiencies.

(i) The institution has not submitted faculty list as per provisions of the NCTE Regulations, 2014 even after sending last reminder (letter).

Hence the Southern Regional Committee decided to confirm the Withdrawal order dt. 13.04.2022. No fresh admissions are permitted now onwards. However, if any student is pursuing M.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn".

- 10. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyapuri, Warangal-506009 Telangana for conducting M.Ed. Programme of two years duration of 50 students for one unit. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- 11. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained

pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(11. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नितिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 12. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
